Thank you for your consultation.

I note that EDF Energy have summarised the comments from DMBC in Table 10.1 of the Consultation Report. However, I did also note in my response to them that no consultation had been carried out within Doncaster, particularly Bawtry and Austerfield. The junction of the A614 and A321, noted within Chapter 7 of the Preliminary Environmental Information Report – Volume I. is located within Bawtry. Therefore traffic associated with the development can be expected to travel through the town. I do however note that Bawtry falls outside of the 10km buffer zone, and our Highways and Transportation teams raise no objection to the proposal in terms of its impact on the Borough of Doncaster.

I should therefore be grateful if the above could be taken into consideration.
