Application by EDF Energy (Thermal Generation) Limited for an Order Granting Development Consent for the West Burton C power station

Accompanied Site Inspection itinerary

I am writing to advise you that the itinerary for the Accompanied Site Inspection (ASI) due to take place on **Tuesday 21 January 2020** has been finalised and can be found below.

This itinerary has been drafted taking account of the Applicant's draft itinerary submitted at Deadline 1 [[REP1-006](#)] and the locations visited as part of the unaccompanied site inspections carried out on 25 September 2019 [[EV-003](#)] and 29 October 2019 [[EV-004](#)]. No other locations have been suggested by any Interested Parties. It is not my intention to return to all locations I have previously visited as part of the ASI. However, I do consider it necessary to return to Viewpoint 4 at Bole and this has been included in the itinerary.

Please note that the ASI is not an opportunity to provide any oral representations; no discussion on the project or evidence will take place. It is solely an opportunity for me to look at the physical features that can be seen on the site and to observe the site from Viewpoint 4. I may invite participants to point out specific features of interest.

Venue

West Burton B reception, located off Gainsborough Road, Retford DN22 9BL.

Access and parking

Free parking is available at the venue.

Joining the site visit

The ASI will commence at 9:00am. Please arrive by 8:30-8:45am at the West Burton A gatehouse located off Gainsborough Road, Retford DN22 9BL to be directed to West Burton B reception and car park. I am not able to wait for parties who are not

present at the start time. Subsequent timings are indicative as it is not possible to determine how much time I will require at a particular location.

If, having seen the itinerary, a person no longer wishes to attend, or only wishes to join the visit at a specific location they should notify the case team (WestBurtonC@planninginspectorate.gov.uk) as a matter of urgency.

To ensure the smooth running of the ExA's inspection, attendees should, **by Thursday 16 January 2020:**

- provide contact details for the day;
- provide car registration number (if driving to site);
- notify the Case Team if there are any changes in attendance; and
- ensure the Planning Inspectorate is made aware of any special access requirements for any participants.

Please note that due to the safety measures in place at the West Burton operational site, it will not be possible to allow access to visitors that have not registered to attend the inspection. Therefore, it is essential, should you wish to attend, that you notify us by Thursday 16 January 2020, as well as providing your vehicle registration number.

Failure to provide this information is likely to mean that you will be unable to attend the inspection at the West Burton site. However, that does not preclude you from attending at the Bole section of the inspection.

Clothing/ PPE

It will be necessary for all parties to wear appropriate sturdy footwear, ideally with ankle support, and weatherproof clothing.

The Applicant will ensure that hard hats, high visibility jackets, safety glasses and gloves will be provided to those in attendance when needed.

In addition, **PPE will be required** to enter operational areas. **Attendees are therefore requested to provide details of boot size and overalls size (S, M, L, XL) no later than Thursday 16 January 2020.**

Transport arrangements

The Applicant will provide a minibus for the visit.

Refreshments

Please note refreshments or lunch will not be provided. A lunch break has not been included in the itinerary and if the visit lasts longer than expected attendees will be expected to provide their own.

Cancellations

Please note that in the unlikely event that the ASI is cancelled due to unforeseen circumstances, we shall endeavour to contact attendees beforehand. However, I

Time	Activity
8:30am – 8:45am	Arrive at the West Burton A gatehouse located off Gainsborough Road, Retford DN22 9BL. The gatehouse security will direct you to West Burton B car park and reception (meeting point).
9:00am – 9:15am	Introductory remarks from the ExA, Safety Briefing and visitor induction in West Burton B reception.
9:30am – 11:00am	Depart West Burton B reception. Drive through the West Burton site to 'turning area'. Continue route on foot to view northern part of the site. Return on foot to 'turning area'. Drive back to West Burton B reception.
11:15am – 12:15pm	Exit West Burton site and follow the route to Viewpoint 4, Bole.
12:30pm	Return to West Burton B reception and end of ASI.
