Thank you for this. I would like to submit the following written representation.

I have no real objection to DS Smith replacing an existing facility but my submission is this company have misled planners and local residents in the past and cannot be trusted.

They with others applied for permission for a sustainable energy plant to serve Kemsley Mill. Planning application SW/10/444 This proved to be an energy from waste plant now known as the Wheelabrator Kemsley Generating Station., and has little to do with the mill and was never mentioned in their application. I feel this was intended to confuse gullible councillors. The planning application also stated they would investigate bringing the waste in by rail. This has not happened and was obviously never going to as there is no infrastructure on the rail network for this sort of thing. They now admit that the rubbish will come by road leading to considerable increase in traffic pollution.which I feel proves my point they cannot be trusted. I have complained to KCC about this.

The mill was granted permission subject to numerous conditions which in my judgement they have not kept.

They also regularly breach their Environment Agency operating licence in allowing noise from the mill to exceed the site boundary. On at lest 25 occasions since January 2017 I have recorded noise nuisance from the mill. They did install monitoring equipment in my garden and the noise did show up on their equipment.

I have reported this to the mill and Environment Agency on numerous occasions..

6 DESCRIPTION OF THE PROJECT AND ITS SETTING

- The consented Generating Station already allows the plant to operate at up to 49.9 MWe (gross) but the Applicant now wishes this maximum operational limit to increase up to an expected 75 MWe (gross). The power upgrade is the only reason for needing to seek a DCO. However, in order to secure one complete consent for the facility, the applicant will also seek consent for its construction and operation. There will be no change to the types and quantum of fuel throughput, nor any changes to emissions in comparison with the consented facility.
- The EIA submitted with the application for Development Consent will assess the entire Project which comprises the Generating Station, the IBA Recycling Facility and the use of the already constructed access road. However, the IBA Recycling Facility does not form part of the application seeking Development Consent. The Site, its location and the proposed layout are shown at Figures 1, 2 and 4 respectively.
- 6.3 The detailed design of the Project is now at an advanced stage and the EPC Contractor is in its first year of the construction programme, main activities being the civil works on site. Timing for the construction and operation of the development is as follows:
 - Construction work started in Quarter 3 of 2016 and will take approximately 36 months. The construction phase is therefore anticipated to be completed by Quarter 3 of 2019; and
 - The Proposed Development is expected to commence full commercial operation in Q3 of 2019.
- 6.4 It is envisaged that the project will have an operating life of up to 40 years and so decommissioning would be currently anticipated to commence in approximately 2059.
- Power output will be influenced by the amount of fuel throughput and the Net Calorific Value (NCV) of the fuel which will vary depending on the fuel content. The anticipated fuel throughput of the facility is between 500,000 to 550,000 tonnes per annum (tpa) with an assumed average NCV of 10.5 MJ/kg, but the range is expected to vary from 8.5 to 13 MJ/kg. Electricity generation does not vary with NCV.
- The fuel used by the Generating Station will be delivered by road. As the plant is a merchant facility it will be capable of accepting fuel from a variety of sources which themselves may change over the lifetime of the plant. The preferred transport route for different fuel contracts will be determined on a case by case basis through discussions with the fuel supplier, based on proximity to the site, volume of fuel, and the prevailing economic considerations at the time. However, for assessment purposes, and based upon the assumptions used on the consented facility, it has been assumed that some fuel will be sourced from within the county of Kent with the balance from London, the South East and elsewhere in the UK.
