Examining Authority's itinerary for an Accompanied Site Inspection

1. Accompanied Site Inspection

Further to the procedural decision and timetable enclosed with my Rule 8 letter of 24 July 2018, I confirm that I will be undertaking an Accompanied Site Inspection (ASI) and request that the following named Interested Parties (IPs) attend:

1. DS Smith Paper Ltd (the Applicant)
2. Kent County Council (KCC)
3. Swale Borough Council (SBC)
4. Environment Agency (EA)

I will be undertaking a site inspection on **Wednesday, 12 September 2018** and the arrangements for this ASI and location are set out below.

Venue: The Site Office, DS Smith Kemsley Paper Mill, ME10 2TD. Meet in the Reception Office.

Access and parking: Free parking available at the venue

The site inspection will involve some walking and I therefore request that all attendees wear appropriate clothing for the weather, and sturdy footwear.

I would like to remind all participants that the site inspection is **not** an opportunity to make any oral representations on the application, but simply an opportunity to identify physical features that are relevant to the examination.

Please note that the ASI itinerary is predominately being undertaken within the confines of the DS Smith Kemsley Paper Mill site. The itinerary for the ASI is set out below with an illustrative plan included at **Annex A**.

2. Accompanied Site Inspection - Itinerary

The ASI will begin at **10.00am** promptly and attendees are requested to arrive by 9.45am in the Reception Office of the DS Smith Kemsley Paper Mill.

1. **09:45am** Compulsory safety briefing
2. **10:00** Inspection of the K4 Proposed site
3. Inspection of the K1 Facility (Work No.5)
4. Inspection of the Low/Medium Pressure steam Manifolds, to view one of the key tie-in connection points with the paper mill (Work No.2)
5. Inspection of the Electricity Substation
6. Inspection of the Access road (Work No.4)
7. Inspection of the Laydown Area, to view the construction compound and laydown area (Work No.3)
8. Inspection of Castle Rough Scheduled Monument
9. The ASI will conclude once all relevant matters have been inspected

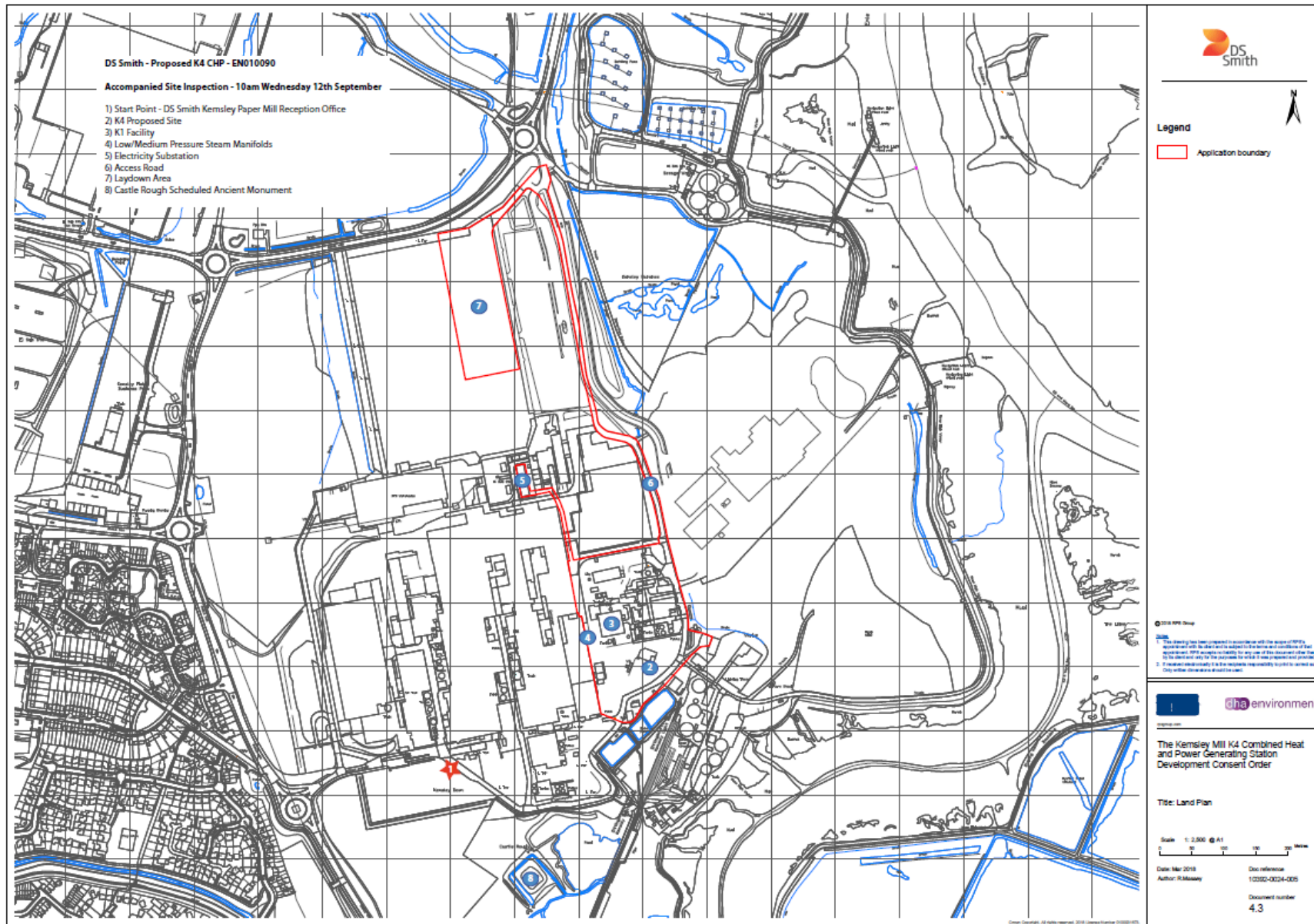
