## Environmental Statement (3.1)

The following elements of the ES have been amended and therefore resubmitted at Deadline 2 to replace the original versions:

- **ES Cover and Contents** amended to reflect updated ES and new Figures
- **ES Chapter 2** an amended Chapter submitted to reflect a number of changes made as a result of responses to ExQ1;
- **ES Chapter 2: Figure 2.2 (a f) –** original Figure 2 split to show individual designations on separate plans;
- **ES Chapter 4: Figure 4.1** reissued to add additional road names to ensure consistency with the ES, in accordance with ExQ1 Q1.8.12
- **ES Chapter 5: Appendix 5.4** revised version provided to address the additional air quality impacts on Ramsar habitats, as requested by the Natural England Written Representation;
- ES Chapter 10: Figure 10.1 (a m) original Figure 10.1 split to show individual designations on separate plans;
- **ES Chapter 10: Figure 10.3** Revised version provided to address ExQ1 Q1.4.8 by showing additional detail to identify buildings a, b and c and a referenced area of vegetation;
- **ES Chapter 13: Summary Tables** an updated set of Mitigation Measures summary tables provided to address ExQ1 Q1.1.17.

#### Statutory Nuisance Statement (5.4)

A revised version of the Statutory Nuisance Statement has been provided which corrects the original reference to an operational management plan to now refer to a Flood Evacuation Plan, which therefore now ensures the document is consistent with Table 9-17 of the Environmental Statement.

#### Statements of Common Ground

Signed Statements of Common Ground (SoCG's) with Swale Borough Council and the Environment Agency were submitted at Deadline 1, together with draft SoCG's with Kent County Council and Natural England.

At Deadline 1 it was envisaged that the NE and KCC SoCG's would be signed by Deadline 2. However, there remain elements of those SoCG's which remain under discussion at this stage. As reflected by the draft SoCG's previously submitted there are no fundamental differences between the applicant and either of the parties and it is envisaged that signed SoCG's will be submitted at Deadline 3.

#### Comments on Written Representations (Document 9.2)

Document 9.2 provides the applicant's response to the Written Representations made to the Planning Inspectorate and refers where necessary to the SoCG's which have been prepared or where discussions are ongoing.



## Responses to ExA First Written Questions (Document 9.3)

Document 9.3 collates the applicant's response to the Examining Authority's First Written Questions. Specific documents have been appended within Document 9.3 and are referred to where relevant in the responses to individual questions. Other documents which have previously been submitted and then amended to reflect the first written questions are identified throughout this letter and within the revised Application Guide.

I trust this summary of the applicant's Deadline 2 submission is useful but would be pleased to discuss further should there be any queries at this stage.
