# 1 Introduction

## 1.1 Purpose of this document

1.1.1 This Application Guide provides a summary of the application by **DS Smith Paper Ltd** for a **Development Consent Order** to allow for the construction of “K4” a **Combined Heat and Power (CHP) plant** at the Kemsley Paper mill, to the north of Sittingbourne in Kent.

1.1.2 This document provides an accessible guide to the scheme, applicant and application to assist those reviewing the application documents. It will be updated as the examination of the DCO application progresses, to record any revisions made to the original application documents and any new documents submitted during the course of the examination, together with providing explanatory notes as required.

## 2 The Scheme

### 2.1 Context to the DCO application

- 2.1.1 DS Smith Paper Ltd are seeking a Development Consent Order to allow for the construction and operation of a Combined Heat and Power (CHP) Plant, 'K4', at the Kemsley Paper Mill to the north of Sittingbourne in Kent, to replace an existing CHP plant 'K1'.
- 2.1.2 The project is a Nationally Significant Infrastructure Project under Section 14 and Section 15 of the Planning Act 2008 as it comprises an onshore generating station with a thermal capacity of more than 50 megawatts. An application for a Development Consent Order must therefore be made to the Planning Inspectorate, with a final decision on the application to be taken by the Secretary of State for Business, Energy and Industrial Strategy.
- 2.1.3 The draft Order is 'The Kemsley Mill K4 Combined Heat and Power Generating Station Development Consent Order'.

### 2.2 The Site and its surroundings

- 2.2.1 The Kemsley Paper mill lies to the east of Kemsley, a residential suburb in the north of Sittingbourne in Kent. The paper mill was first constructed in the 1920's and has since expanded to form a substantial complex of buildings, areas of hardstanding and ancillary systems and equipment.
- 2.2.2 The proposed location of the K4 CHP plant is an area of hardstanding in the south-eastern part of the wider mill complex which is used for various purposes including paper storage and which contains a vehicle weighbridge, a truck wash area, a vehicle refuelling point and a hazardous waste storage area.

### 2.3 The Draft Development Consent Order

- 2.3.1 The draft DCO makes provision for five specific works within the DCO boundary, which encompasses the K4 site, existing energy infrastructure within the mill site and other hardstanding areas within the wider Kemsley Paper mill:
- (1) A combined cycle generating station;
  - (2) The retention of, connection into and continued use of existing infrastructure and tie-ins;
  - (3) A construction compound and laydown area;
  - (4) Retention and continued use of internal access and haulage road;
  - (5) The decommissioning of K1.

## 3 The Applicant

### 3.1 The Applicant – DS Smith Paper Ltd

3.1.1 DS Smith is a leading European manufacturer of recycled corrugated case materials and speciality papers and operates nine paper mills across Europe, with the Kemsley mill its only mill within the UK.

### 3.2 The Project Team

3.2.1 The project team acting on behalf of the applicant comprises the following:

- DS Smith Paper Ltd – applicant and site owner;
- E.ON (trading as Kemsley CHP Ltd)– prospective CHP construction/operation;

### 4.3 Timeline

#### (1) Submission of the DCO Application – 6<sup>th</sup> April 2018 (Volumes 1, 2, 3, 4, and 5)

At the point of submission two potential technical options are being considered; a horizontal or vertical tube boiler. The location of the proposed 70m stack would alter depending on the option chosen, as would the scale of the Heat Recovery Steam Boiler building and the location of some other elements of the proposed development, such as the pipebridge. At the point of submission, Works Plans with limits of deviation, together with illustrative layouts, elevations and 3D visuals have been provided for both options. When one is selected one set of plans will be removed from the DCO application.

#### (2) Response to S51 Advice – 14<sup>th</sup> June 2018 (Volume 6)

Following the acceptance of the application the Planning Inspectorate issued a S51 Advice letter to the applicant (dated 26<sup>th</sup> April 2018) which provided various points of advice regarding the application.

The applicant submitted the following documents in response to the S51 Advice:

### (4) Deadline 2 submissions – 21<sup>st</sup> August 2018 (Volume 9)

Following the closure of Deadline 1, the Examining Authority issued a set of questions and a number of documents were requested to be submitted by the Applicant for Deadline 2 of the Examination (21<sup>st</sup> August 2018).

Following the completion of the tender process, it was confirmed by the applicant that a vertical boiler will be installed. As a result all the plans and references to a horizontal boiler are no longer part of the application for the DCO. The applicant decided to advise the ExA ahead of Deadline 5 and provided additional submissions to amend the application which has been called the Post Deadline 4 Submission (12<sup>th</sup> October 2018).

The applicant has taken the opportunity at Deadline 6 to provide a response to the submissions by the EA and KCC at Deadline 5 of the examination programme, together with providing the applicant's Preferred DCO. The documents comprise:

  - (f) Revised Design and Access Statement (Document 5.3)
- 4.3.2 The subsequent Chapters of this document list the documents and plans which formed the original submission as well as where they have been superseded or are no longer part of the application.

#### **4.4 Other Matters**

- 4.4.1 No compulsory purchase powers or rights over the apparatus of statutory undertakers are being sought within the draft Development Consent Order. For that reason, the DCO application does not include a Book of Reference, a Statement of Reasons, or a Funding Statement.
- 4.4.2 All the necessary technical tie-ins between the proposed plant and existing infrastructure on the Kemsley paper mill site take place within the DCO boundary and no associated development is proposed.
- 4.4.3 There are no altered accesses proposed, and therefore no Access Plan has been provided. There is no Crown Land within the proposal site or the immediate vicinity, so no Crown Plan has been submitted.

- 5.1.1 The **Covering Letter (1.1)** provides a brief introduction to the proposed application and background information. The **Application Guide (1.2)** is this document which provides guidance on the submitted application documents. The **Application Form (1.3)** is the standard form that is required to be completed and provides a high-level summary of the proposed scheme and the documents that have been submitted.
- 5.1.2 The **Copies of Newspaper Notices (1.4)** contains details of the notices published in the local and national newspapers prior to the submission of the application in accordance with s47 and s48 of the Planning Act 2008. These notices publicised the proposed application, the consultation materials, deposit locations and the process for providing comments. Also contained in this document are the s42 letters which were sent to various statutory and prescribed bodies at the pre-application stage to seek their views on the proposed development.

- 6.1.1 The **Draft Development Consent Order (2.1)** would provide consent to DS Smith Ltd to construct and operate the proposed CHP Plant. It defines the parameters of the development and is accompanied by two schedules:
- (1) **Schedule 1 – Authorised Development**: Describes the proposed development for which consent is being sought; and
  - (2) **Schedule 2 – Requirements**: Lists the requirements which relate to the carrying out and operation of the authorised development. Requirements are similar to planning conditions.
- 6.1.2 The **Explanatory Memorandum (2.2)** describes the purpose and effect of each article of and each Schedule to the draft Kemsley Mill K4 Combined Heat and Power Generating Station Development Consent Order as required by Regulation 5(2)(c) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009. As such it should be read alongside the DCO.
- 6.1.3 If granted the DCO would become a statutory instrument. It must therefore be written in accordance with drafting conventions for that type of document; the **Draft Development Consent Order – Validation Report (2.3)** illustrates the result of having the draft DCO reviewed using the Statutory Instrument template tool.

8.1.1 **Documents 4.1 - Context Site Location Plan** and **4.2 - Site Location Plan - Aerial Photo** show the location of the proposed development within the local context. Those plans and **Document 4.3 - The Land Plan** also show the DCO boundary; the land to which the DCO would relate.

8.1.2 **Document 4.4 - Works Plans - Key Plan** shows the extent of the five Works for which consent is sought in the DCO, which are as follows;

- **Work No. 1: Combined Gas Generating Station**

This shows the general area in which the new K4 CHP Plant will be erected. At the point of submission two technical options remain possible; a horizontal tube or vertical tube boiler.

Horizontal tube boiler:

**Document 4.5 - Work No.1 -Works Plan with limits of deviation for horizontal tube boiler** shows the limits of deviation should the horizontal tube boiler option be constructed. The limits of deviation are the maximum extent in which the development and individual works elements would be carried out. **Document 4.6 - Illustrative layout with horizontal tube boiler** provides an indicative layout of the CHP plant within the limits of the deviation. **Document 4.7 - Illustrative Elevation cross sections - Vertical Tube Boiler** shows the indicative elevations of the CHP plant with the horizontal tube boiler from each compass point and **Document 4.8a - Site Context - 3d Visual - Horizontal Tube Boiler (view a)** and **Document 4.8b - Site Context -3d Visual - Horizontal Tube Boiler (view b)** depict how the indicative CHP plant would fit in the wider landscape.

Vertical tube boiler:

**Document 4.9 - Work No.1 -Works Plan with limits of deviation for Vertical Tube Boiler** shows the limits of deviation should the vertical tube boiler be constructed. The limits of deviation are the maximum extent in which the development and individual works elements can be carried out. **Document 4.10 - Illustrative layout with Vertical Tube Boiler** provides an indicative layout of the CHP plant within the limits of the deviation. **Document 4.11 - Illustrative Elevation**

**cross sections – Vertical Tube Boiler** shows the indicative elevations of the CHP plant with the vertical tube boiler from each compass point and **Document 4.12a - Site Context – 3d Visual – Vertical Tube Boiler (view a)** and **Document 4.12b - Site Context – 3d Visual – Vertical Tube Boiler (view b)** depict how the indicative CHP plant would fit in the wider landscape.

- **Work No. 2: Tie-ins**  
This identifies the general area in which the K4 CHP Plant will be integrated into the existing infrastructure and services within the wider paper mill complex, with those tie-ins included within the DCO boundary. The indicative connection points and details are shown in **Document 4.13 - Work No.2 Plan – Tie-ins to existing site facilities (illustrative)**.
- **Work No. 3: Construction laydown area**  
This shows the general area for the temporary receipt and storage of construction materials, equipment and supplies as well as for partial assembly.
- **Work No. 4: Construction Access**  
This identifies the access point for all construction vehicles and the internal access and haulage road within the site itself.
- **Work No. 5: Decommissioning of K1**  
This shows the location of the K1 CHP plant. The decommissioning of the existing K1 CHP plant comprises works to make K1 inoperable, however, no physical demolition of the existing K1 structure is proposed as part of the DCO being sought.

8.1.3 **Document 4.14a - Nature Conservation Plan** identifies the site in relation to environmental designations within the wider area. This includes Air Quality Management Areas, Special Protection Areas and RAMSAR sites, Sites of Special Scientific Interest (SSSI), Local Wildlife Sites and Flood Zones 2 and 3. **Document 4.14b - Habitats Plan** identifies the site in relation to biodiversity designations such as priority habitats, habitats and species records.

8.1.4 **Document 4.15 - WFD Waterbodies in a River Basin Management Plan** identifies the site in relation to local water bodies. **Document 4.16 - Heritage Plan** identifies the site in relation to heritage assets which are Listed Buildings, Conservation Areas and Scheduled Monuments.

- 8.1.5 **Document 4.17 – Site Level Plan** identifies the site levels above ordnance datum (AOD). This has been submitted at Deadline 5 following the completion of the tendering process for the type of boiler to be installed. The successful tenderer will install a vertical boiler.
