Compulsory Acquisition Hearing, 2.00pm (Doors open at 1.30pm) at Goole Leisure Centre, North Street, Goole DN14 5QX

Details and arrangements for these hearings are set out at **Annex A**.

We would be grateful if you would inform us if you plan to attend any of the hearings (even if you do not wish to speak) **no later than 22 November 2018**. It would also assist us if you could notify the Planning Inspectorate's case team of any special needs you may have (eg: disabled access, hearing loop etc). Please ensure that you include your Interested Party reference number in all correspondence. This can be found either in the email covering this letter or on the postcard you have received.

The time allocated for each of the hearings has been estimated based on the matters identified for consideration. Should a hearing take less time than anticipated, the ExA may conclude the hearing as soon as all relevant contributions have been made and all questions asked and responded to. Equally, if there are additional matters to be dealt with or there are submissions that take a considerable amount of time at any hearing, there may be a need to continue the session for longer on the day, or adjourn the hearing and continue at a subsequent sitting. Alternatively, the ExA may choose to prioritise certain matters and defer others to further written questions, to be issued on Tuesday 15 January 2018.

An agenda for each of the hearings will be published on our website in the week before each event.

### **Accompanied Site Inspection**

In addition to the hearings above, an ASI is scheduled to take place on **Tuesday 4 December 2018**. Details and arrangements for the ASI are set out at **Annex B**.

The site inspection will begin at the **Drax Sports and Social Club, Main Road, Drax, Selby YO8 8PJ** at **10.00am**. Transport will be provided to take attendees for a tour of the application site followed by an inspection of a number of locations in the vicinity.

Attendees are reminded that the purpose of the site inspection is to view the site and surroundings in the context of the written material. No representations should be made, or discussions on points of merit conducted, at this inspection.

The inspection will include some walking on uneven or wet ground. The Planning Inspectorate therefore advises attendees to wear clothing that is appropriate for the weather, and sturdy footwear. Personal Protective Equipment (PPE) can be provided by the applicant.

Due to the requirement to wear PPE whilst on the application site and security requirements, and because capacity on the minibus that will be used for the ASI is limited, we would be grateful if parties wishing to attend could advise the case team in writing (email or post) by **22 November 2018** indicating:

- Your boot size for PPE if not bringing sturdy footwear
- If you have restricted mobility and require a vehicle with wheelchair access
- Any other special needs you may have
