With regard to agenda items on which we wish to speak, please note the following:

- 1. We are not proposing to speak on the principal issues or the draft timetable set out in the Rule 6 letter, save to respond to any issues raised by the inspector or other parties;
- 2. We do have some observations to make relating to the list of SOCGs detailed in Annex E to the Rule 6 letter. In particular, there are certain parties with which the Applicant is not intending to enter into an SOCG at this stage, but this will be kept under review in advance of the deadline for submission of SOCGs as set out in the draft timetable; and
- 3. There are two potential changes to the Applicant's scheme with regard to which the Applicant has entered into discussions with stakeholders following publication of the Relevant Representations. The Applicant will be in a position to update the ExA at the Preliminary Meeting once final decisions have been made as to whether it intends to make a formal request in respect of these potential changes. The Applicant does not consider it helpful to try to summarise the potential changes in this email, as discussions with relevant stakeholders are ongoing at this time.

More generally, I would like to mention the following:

1. We are close to finalising the Cumulative Environmental Assessment addendum which is referenced in paragraph 15 of the application covering letter;

- 2. We have commissioned a Navigation Risk Assessment in relation to the causeway;
- 3. We are finalising an addendum to Appendix 1 of the Planning Statement, which we are intending to share shortly with Thurrock Council to assist in its consideration of its Local Impact Report.

We will be asking in due course that these documents are accepted into the Examination and will update the position on these documents as appropriate at the Preliminary Meeting.
