- *Submission of written responses to matters discussed at the Preliminary Meeting (Part 1);*

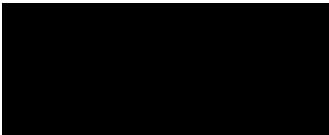
This Council does not wish to make any written responses to matters discussed at the Preliminary Meeting (Part 1);
