Overview

Appendix B.1 comprises five tables listing consultees identified in accordance with Schedule 1 of the Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (APFP Regulations) and section 42(1)(a), (aa), (b) and (c) of the Planning Act 2008 (PA 2008) that the Applicant consulted under section 42 of the PA 2008.

The tables below also identify the consultees that were formally consulted by PINS as required by Regulation 11 of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (as amended) (the ‘EIA Regulations 2017’) (the ‘Regulation 11 List’) (see **Section 4** of the Consultation Report for further details). Advice Note 3: EIA Notification and Consultation (PINS, version 7, August 2017) (‘PINS Advice Note 3’), states that “*applicants may use this list to inform their pre-application consultation, but should not rely on this when carrying out their own s42 consultation exercise*”, therefore the tables below also provide a commentary outlining where changes have been made to the original Regulation 11 List (provided by PINS in January 2018), following further inquiries through the pre-application process.

As part of its consultation on the EIA Scoping for the Proposed Development, PINS identified the Royal National Lifeboat Institute (RNLI) as a non-prescribed consultee. No consultees under Regulation 11(1)(c) were identified to the Applicant in the Regulation 11 list. The Applicant has also elected to consult bodies other non-prescribed bodies.

The Tables are organised as follows:

- Table 1 lists Prescribed Consultation Bodies in Schedule 1 of the APFP Regulations consulted under section 42(1)(a) and the Marine Management Organisation under section 42(1)(aa), in accordance with Advice Note 14, they are listed in the order in which they appear in Schedule 1 to the APFP Regulations;

- Table 3 lists non-prescribed bodies that the Applicant consulted as though they were section 42(1)(a) consultees;

In some instances, as a result of the evolution of the Proposed Development through the pre-application, some parties were no longer considered by the Applicant to fall within the scope of the relevant statutory provision. Where this occurs it is noted in the table.
