The PLA has the following submission to make at Deadline 3.

Discussions with the Applicant have resulted in the submission of the agreed Statement of Common Ground.

Paragraphs 3.2 and 3.3 of the PLA's Written Representations described the amendments in the Works Plans and the DCO that have been agreed with the Applicant. The PLA has not seen the revised dDCO which it is understood is to be submitted at D3, so cannot check the position, but we have received confirmation from the Applicant's solicitors that "no amendments have been made to the agreed Article (as per the SoCG) and no other amendments relate to the Port of London Authority".

While there is no reason to suppose that any future amendments will have a bearing on the amendments the PLA has agreed with the Applicant, the PLA will need to monitor future iterations of the DCO. Its agreement will not therefore be withdrawn for the moment so that it can if necessary make further representations. However, barring unexpected amendments to the DCO or the Works Plans, the objection will be withdrawn before the end of the examination.

Will you please confirm that this submission will be passed to the ExA.
