Joint Statement between the Applicant and the Western Riverside Waste Authority

Dear Dee,

I set out below a joint statement agreed between Applicant and the Western Riverside Waste Authority (the “**WRWA**”). I should be grateful if you would pass this statement on to the Examining Authority.

I copy in the WRWA’s lawyer to confirm that this statement is agreed:

*“The Applicant and the Western Riverside Waste Authority (the “**WRWA**”) are continuing in their discussions with the aim of reaching a voluntary agreement. To this end, meetings were held on 17th June and 27th June 2019 and another is scheduled for 22 July 2019. Given this and the recent compulsory acquisition hearing held on the afternoon of 6 June 2019 and the morning of 7 June 2019, which was devoted to the WRWA, the Applicant and the WRWA both agree that:*

- *at Deadline 4, the WRWA will not submit comments on the Applicant’s post hearing written submissions of oral case or any additional information submitted at Deadline 3 but may do so at Deadline 5; and*
- *it is not necessary for the WRWA to attend any compulsory acquisition hearing on 30 or 31 July 2019.”*
