3.2 In addition to the above, the Applicant and Kent County Council have continued to discuss two matters relating to the advanced draft of the SoCG submitted at Deadline 2. Only one outstanding matter remains in respect of proposed amendments by the Applicant to the Outline CTMP to seek to minimise any potential effects to the Fastrack bus route. All other matters remain as set out in the previously submitted advanced draft SoCG, except for an agreed change in respect of the Archaeology Requirement 7 which has been discussed and agreed further between the parties in light of discussions at the Issue Specific Hearing on the draft Development Consent Order. This change is reflected in the Deadline 5 version of the dDCO (Rev 3, 3.1). Although an updated draft SoCG has not been submitted at Deadline 5, it is

the Applicant and KCC's expectation that an agreed and signed SoCG will be submitted imminently.
