**EXAMINATION OF THE RIVERSIDE ENERGY PARK DEVELOPMENT
CONSENT ORDER APPLICATION BY CORY ENVIRONMENTAL HOLDINGS

1. We write on behalf of Western Riverside Waste Authority ("**WRWA**") in respect of the REP Application which was accepted by the Secretary of State for examination on 14 December 2018.
2. Following recent discussions between WRWA and Cory Environmental Holdings Limited ("**Cory**"), we can confirm that a commercial agreement has been reached which resolves WRWA's objections to the REP Application and includes the acquisition of WRWA's interests in the Order land.
3. On this basis, we can confirm that WRWA no longer wishes to participate in the Examination and it withdraws all of its representations, submissions and objections made to the Examination, including those representations, submissions and objections set out in the following documents:

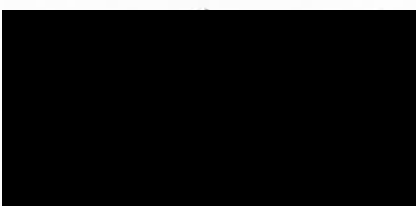
