Riverside Energy Park: Proposed Integrated Energy Park, Belvedere, London (EN010093)

- 1. DEADLINE 8 SUBMISSION LETTER (DOCUMENT REFERENCE 8.02.75)
- 1.1 Further to the Examining Authority's (ExA) Rule 8(3) Letter dated 3 September 2019, I am pleased to enclose the documents requested by the ExA for Deadline 8.
- 1.2 At the Issue Specific Hearing on the draft Development Consent Order held on 19 September 2019, it was discussed that Deadline 8 should be split into a Deadline 8, a Deadline 8a and Deadline 8b. The reason for this split was to enable the Applicant to circulate updated drafting on various Requirements contained in Schedule 2 to the draft Development Consent Order to the LBB and the GLA in order to try and reach agreement prior to the end of the Examination. To this end, it was discussed, and the LBB and the GLA agreed, that the following split would benefit the Examination process:
  - 1.2.1 Deadline 8 (23 September 2019):
    - (a) Comments on any additional information/submissions received by the previous Deadline;
    - (b) Any signed SoCGs;
    - (c) Post Hearing submissions including written submissions of oral case; and
    - (d) Responses to any further information requested by the ExA.

- 1.2.2 Deadline 8a (30 September 2019):
  - (a) Applicant's responses to comments on the draft Development Consent Order;
  - (b) Final draft of the Development Consent Order together with SI validation; and
  - (c) Final SoCGs.
- 1.3 The Applicant does not consider that there is a need for a Deadline 8b, given the current timetable does not enable comments on the final draft Development Consent Order, but at the ISH the GLA suggested that a Deadline 8b would be helpful. This Deadline would fall on 4 October 2019 (which the GLA indicated would be acceptable).
- 1.4 For the purposes of this Deadline 8, the Applicant has followed the division of documents as discussed at the Issue Specific Hearing held on 19 September 2019.
- 1.5 Where a previous document has been updated, a clean and track changed version has been submitted. The versions that show the track changes have the same document reference but are named '(with track changes)'.
- 1.6 Where a new submission document is being issued that is linked to a document in the original volumes, it has been given a sequential number to that volume. All other new documents will be issued within volume 8. All documents with a reference starting 8.01.## will be Statements of Common Ground and all other documents will fall under the numbering system 8.02.##.
