RIVERSIDE ENERGY PARK ORDER 2020 – NOTIFICATION PURSUANT TO ARTICLE 9(5) OF THE ORDER OF THE PROPOSED TRANSFER OF THE BENEFIT OF THE ORDER TO RIVERSIDE ENERGY PARK LIMITED PURSUANT TO ARTICLE 9(4)(A) OF THE ORDER

We act for Cory Environmental Holdings Limited (**CEHL**) and write in respect of the Riverside Energy Park Order 2020 (the **Order**).

As you are aware, the Order was made by the Secretary of State for Business, Energy and Industrial Strategy on 9 April 2020 and came into force on 1 May 2020. The Order authorises the construction, operation and maintenance of an integrated energy park of over 50 MW generating capacity and associated electrical connection located at Belvedere in the London Borough of Bexley.

CEHL proposes to transfer all of the benefit of the Order to its wholly owned subsidiary Riverside Energy Park Limited (**REPL**), using the powers contained in Article 9 of the Order. A copy of the completed Transfer Agreement to transfer the full benefit of the Order to REPL is enclosed with this letter. The effective date on which the transfer will take effect is 4 January 2022.

Under Article 9(4)(a) of the Order, where the transfer or grant is made to REPL (and in circumstances where REPL is a wholly owned subsidiary of CEHL), CEHL is required to notify the Secretary of State, rather than seek their consent under Article 9(1). As evidenced in the attached notice, REPL is a wholly owned subsidiary of CEHL and so Article 9(4)(a) is applicable to this transfer. Please therefore find enclosed a notice pursuant to Article 9(5) of the Order.

We would be grateful if you could confirm receipt of this letter and its enclosures as soon as practicable.
