Thank you for your email and offering us the opportunity to comment on the adequacy of consultation.

I am able to confirm that Boston Borough Council considers that the documents presented sufficiently demonstrate that the obligations under S42,47 & 48 of the Planning Act 2008 have been met. The documents are comprehensive in nature; and based on the engagement with Boston Borough Council to date, we are confident that the applicants have approached this in a positive way as per the spirit of the regulations.

It is noted that the final consultation this year elicited a poor response as it was on-line only - webinar and response form; the method of consultation was owing to Covid-19. Previous consultation using traditional face to face forums were better attended and responded to. However, these minor points do not undermine our overall view that the pre-consultation has been adequately approached.

I hope that this is sufficient for your purposes.

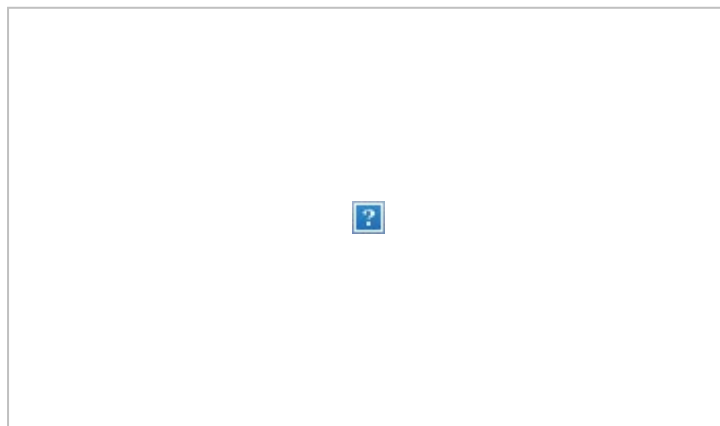
