## Date, time and meeting place for the Accompanied Site Inspection

Please be advised that the Examining Authority will hold an Accompanied Site Inspection (ASI) under Rule 16 of the Infrastructure Planning (Examination Procedure) Rules 2010 on Wednesday 17 November 2021 commencing at 9:45am. The meeting place is the Station Approach Car Park. Access is from Station Approach, off the A52 or Station Street. The address is 11 Station Approach, Boston, PE21 8RN.

Areas to be visited on this ASI are as set out in the final agenda, listed in Annex A of this letter. They will be the Fishing Quay on London Road, the main works area at Riverside Industrial Estate and surroundings, viewpoints of significant effect, tree screening near the entrance to Metsa Wood and the Golf Yard on Fishtoft Road. The ExA also plans to view the Mouth of the Haven later in the day as an USI.

The itinerary for the Accompanied Site Inspection (ASI) can be found below.

It is an opportunity for the ExA to look at the physical features that can be seen on, or from the sites. Participants may be invited by the ExA to point out specific features or sites of interest.

## Joining the site visit

The site inspection will commence at 9.45am at the Station Approach Car Park. Participants are asked to assemble promptly as the ExA will not wait for parties who are not present at the start time.
