1 Introduction

1.1 Overview

1.1.1 This 'Application Guide' document has been prepared on behalf of Alternative Use Boston Projects Limited (the Applicant). It forms part of the application (the Application) for a Development Consent Order (DCO), that has been submitted to the Secretary of State (SoS) for Business, Energy and Industrial Strategy, under section 37 of the Planning Act 2008.

1.1.2 The Applicant is seeking development consent for the construction, operation and maintenance of a power-generation plant, known as the Boston Alternative Energy Facility (herein 'the Facility'). The Facility is primarily located on land at Riverside Industrial Estate, Boston, Lincolnshire (the Application Site).

1.1.3 A DCO is required for the Facility as it falls within the definition and thresholds for a 'Nationally Significant Infrastructure Project' (NSIP) under sections 14 and 15(2) of the Planning Act 2008. The DCO, if made by the SoS, would be known as the 'The Boston Alternative Energy Facility Order' (the 'Order').

1.2 The Applicant

1.2.1 The Applicant is a privately-owned company. The Applicant's core business is Energy from Waste (EfW), specifically renewable electricity projects producing "Green Energy".

1.2.2 The company team has been involved in industrial development at the site in Boston, Lincolnshire since 2004. In March 2005 planning consent was obtained for a Special & Clinical Waste Processing Plant, with conditions discharged and construction started.

1.2.3 In 2010 consent was obtained for a 12 megawatts electric (MWe) Gasification Power Station that would process waste wood (known as Boston Biomass Plc) with enabling works carried out during 2013. This facility was sold to Aviva Investors in November 2015, along with the right to develop the facility, and in September 2016 it was transferred to Biomass UK No. 3 Ltd. The Biomass UK No. 3 Ltd facility is entirely separate to the proposed Facility.

1.3 The Application Site

1.3.1 The 26.8 hectare (ha) Application Site for the Facility is located approximately 2 km to the south east of Boston town centre and comprises two components:

- the Principal Application Site (NGR TF33950 42241), which covers 25.3 ha and will contain all of the operational infrastructure; and
- the Habitat Mitigation Area, which covers 1.5 ha and is located approximately 170 m to the south east of the Principal Application Site, encompassing an area of saltmarsh and small creeks at the margins of The Haven that will be enhanced.

1.3.2 The Principal Application Site is neighboured to the west by the Riverside Industrial Estate and to the east by The Haven, a tidal waterway of the River Witham between The Wash and the town of Boston. The A16 public highway is approximately 1.3 km to the west.

1.3.3 The Application Site is wholly located within the jurisdiction of Lincolnshire County Council (LCC) and Boston Borough Council (BCC) local planning authority.

1.3.4 The Principal Application Site is accessed by road via the Riverside Industrial Estate's existing road network from Nursery Road. Access to the site from the west to Marsh Lane is gained from Bittern Way.

1.3.5 The Principal Application Site comprises undeveloped and previously developed land enclosed by a network of drainage ditches and forms part of a wider emerging industrial/commercial area.

1.3.6 The eastern margins of the Principal Application Site are defined in part by a primary flood defence bank along The Haven. Large and small industrial business units are located to the north, west and south of this site. A 132 kV overhead powerline on pylons bisects the Principal Application Site in a north-south direction.

1.3.7 A more detailed description of the Application Site is provided in the **Environmental Statement (ES) Volume 1 Chapter 5** (documents reference 6.2.5, APP-043).

1.4 The Proposed Facility

1.4.1 The Facility is an EfW plant that would generate approximately 102 MWe (gross) of renewable energy and would deliver approximately 80 MWe (net) to the National Grid. The energy recovery plant would be a thermal treatment facility using refuse derived fuel (RDF) as the feedstock to generate energy. A full project description is given in the **Environmental Statement (ES) Volume 1 Chapter 5**

1.4.2 The main elements of the Facility are:

- a wharf and associated infrastructure (including re-baling facility, workshop, transformer pen and welfare facilities);
- a RDF bale contingency storage area, including sealed drainage, with automated crane system for transferring bales;
- conveyor system running in parallel to the wharf between the RDF storage area and the RDF bale shredding plant. Part of the conveyor system is open and part of which is under cover (including thermal cameras);
- bale shredding plant;
- RDF bunker building;
- thermal treatment plant comprising three nominal 34 MWe combustion lines (circa 120 megawatts thermal (MWth)) and associated ductwork and piping, transformer pens, diesel generators, three stacks, ash silos and ash transfer network; and air pollution control residues (APCr) silo and transfer network;
- turbine plant comprising three steam turbine generators, make-up water facility and associated piping and ductwork;
- air-cooled condenser structure, transformer pen and associated piping and ductwork;
- Lightweight Aggregate (LWA) manufacturing plant comprising four kiln lines, two filter banks with stacks, storage silos for incoming ash, APCr, and binder material (clay and silt), a dedicated berthing point at the wharf, silt storage and drainage facility, clay storage and drainage facility, LWA workshop, interceptor tank, LWA control room, aggregate storage facility and plant for loading aggregate / offloading clay or silt;
- electrical export infrastructure;
- two carbon dioxide (CO₂) recovery plants and associated infrastructure, including chiller units;
- associated site infrastructure, including site roads, pedestrian routes, car parking, site workshop and storage, security gate, control room with visitor centre and site weighbridge; and
- habitat mitigation works for redshank and other bird species comprising of improvements to the existing habitat through the creation of small features such as pools/scrapes and introduction of small boulders (Habitat Mitigation Works) within the Habitat Mitigation Area.

1.5 The Purpose and Structure of this Document

- 1.5.1 The purpose of this Application Guide is to list the documents (Application Documents) that make up the Application submitted to the SoS. In addition, it sets out how the Application Documents submitted comply with relevant legislative and policy requirements and guidance.
- 1.5.2 The Application Guide will be updated by AUBP, as required, during the examination of the Application by the SoS and documents that have been superseded will be clearly identified as such.
- 1.5.3 The Application Documents are listed in **Section 2 (Table 2-1)** of this document.

2 Application Documents

- 2.1.1 The Application Documents have been grouped into appropriate categories and each has been given its own document reference in **Table 2-1** on the following pages.
- 2.1.2 In addition to listing the Application Documents submitted, **Table 2-1** also identifies where these have been provided to comply with relevant legislative requirements, or specific policy and relevant guidance. The legislative requirements for DCO applications are principally contained in the Planning Act 2008, the Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (APFP Regulations) and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (EIA Regulations). Specific policies are set out in relevant energy National Policy Statements (NPSs) including the Overarching Policy Statement for Energy (EN-1) and the National Policy Statement for Renewable Energy Infrastructure (EN-3).
- 2.1.3 Regulation 5 in the APFP Regulations lists the documents that all DCO applications must include. Regulation 5 includes a category (Reg. 5(2)(q)) described as "any other documents considered necessary to support the application". Similarly, Regulation 5 (Reg. 5(2)(o)) also allows applicants to submit other plans, drawings and sections which are considered necessary to describe the project. The documents and plans and drawings that have been provided by AUBP under these categories of Regulation 5 are therefore not statutorily required but are those which it considers are necessary to explain and support the Application.
- 2.1.4 Regulation 6 in the APFP Regulations sets out a number of documents that particular types of DCO application must include. Those relating to generating stations are relevant to the Facility and include a Grid Connection Statement.
- 2.1.5 The Application submitted for the Facility is considered to comply with the statutory requirements of the Planning Act 2008, the APFP Regulations and the EIA Regulations, and also with the applicable Secretary of State and Planning Inspectorate guidance, including PINS Advice Note 6 'Preparation and submission of application documents' (November 2019, version 8).
