**VPI IMMINGHAM OCGT PROJECT – APPLICATION FOR A NEW GAS-FIRED POWER STATION AND ASSOCIATED DEVELOPMENT – LAND TO THE WEST OF ROSPER ROAD, SOUTH KILLINGHOLME, LINCOLNSHIRE, DN40 3DZ**

**APPLICANT’S SUBMISSION FOR DEADLINE 2 OF THE EXAMINATION**

I write on behalf of VPI Immingham B Limited (‘VPIB’ or the ‘Applicant’) in respect of the application (the ‘Application’) for a Development Consent Order (‘DCO’) to construct, operate and maintain a new gas-fired electricity generating station with a gross output capacity of up to 299 megawatts (‘MW’), including electrical and gas supply connections, and other associated development (the ‘Proposed Development’).

The Proposed Development is located primarily on land (the ‘Site’) to the north of the existing VPI Immingham Power Station, Rosper Road, South Killingholme, North Lincolnshire, DN40 3DZ.

The Application was accepted for examination (the ‘Examination’) on 9 May 2019 and the Examination began on 09 August 2019. This letter and enclosures comprise the Applicant’s submission for Deadline 2 of the Examination. The submission comprises the following documents, as requested by the Examining Authority (‘ExA’):

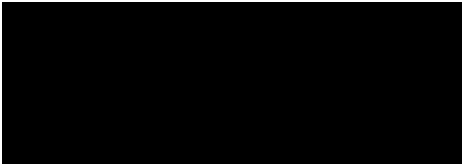
