Statements of Common Ground

The Statement of Common Grounds ('SoCG') referred to above are submitted in draft. They are currently with North Lincolnshire Council ('NLC') and Natural England ('NE') for what the Applicant hopes is final review and signing. The Applicant will provide an update on this at Deadline 4 of the Examination.

In respect of the NLC SoCG, the Applicant can confirm that all matters, aside from Requirement 19 and Schedule 10 of the Draft Development Consent Order (Document Ref: 2.7), have been agreed with NLC. This includes agreement in respect of the Framework Written Scheme of Investigation (see section 13 'Cultural Heritage' in the SoCG). Please note that the SoCG has been drafted with all matters agreed, but this is subject to sign-off by NLC.

In respect of the NE SoCG, the Applicant is seeking agreement in respect of noise disturbance on the Humber Estuary SPA / Ramsar Bird species (see section 4.3 of the SoCG). The Applicant has provided further clarification on this matter in the SoCG and Statement to Inform Appropriate Assessment (Document Ref: 7.13). It is our understanding that all other matters are substantively agreed. Please note that the SoCG has been drafted with all matters agreed, but this is subject to sign-off by NE.

I trust that this letter provides the information required from the Applicant for Deadline 3 of the Examination.

I would be grateful if you could confirm receipt of this letter.
