Dear Sir,

We act on behalf of Network Rail Infrastructure Limited in relation to this matter and respond to question 1a.1.6 which is ascribed to Network Rail as set out in the Rule 17 letter dated 24 October 2019:

Q1a.1.6:

"Please provide an update on discussions and give an indication of whether there is likely to be a need to hear oral evidence on any outstanding matters relating to CA or TP. If so, please indicate the matter(s) upon which it is considered that oral evidence should be heard."

Network Rail's response to Q1a.1.6:

Network Rail are yet to receive a first draft of the proposed option for an easement from the Applicant's solicitors and, once received, that document will be reviewed. No detailed comments have been received in relation to the Network Rail proposed Protective Provisions set out in Network Rail's written representation [REP2-022]. At present, Network Rail does not consider that it will need to give oral evidence on any outstanding matters related to CA or TP. Network Rail will, however, keep the Examining Authority updated in relation to progress in terms of discussions with the Applicant and will respond to any questions raised by the Examining Authority.
