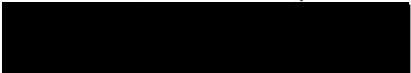
We are still in discussions with the Applicant with regards to both a side agreement and protective provisions. These discussions have not progressed materially since the oral hearings but we remain hopeful of reaching agreements on protections which will provide sufficient comfort for Hornsea 1 in due course. We are not however, currently in a position to confirm if or when this agreement will be achieved.

We do not, at this stage, consider it necessary to set further hearings to hear oral evidence in respect of our objection and consider that supplementary points can be made in writing. We reserve our position however to attend any future hearings which the Examining Authority considers it appropriate to set.
