Application by VPI Immingham B Ltd (the "Promoter") for an Order Granting Development Consent for the VPI Immingham OCGT Project

Further to the Rule 17 letter dated 24 October 2019, we address the Examining Authority's additional question with reference 1a.1.2 on behalf of our client Cadent Gas Limited.

The Promoter confirmed directly to our client on 31 October 2019 that as a result of a site visit of on 30 October 2019, Plot 111 will be removed entirely from the Land Plans and that Plot 107 and 109 will be removed in so far as they relate to land within Cadent's outside fence line.

We have been pushing the Promoter to provide comments on Cadent's standard form protective provisions, however we have not yet received comments back on these. Cadent welcomes engagement by the Promoter.

In the event that Plots 107, 109 and 111 are removed from the Land Plans as indicated, and suitable protective provisions can be agreed, Cadent does not anticipated the need to give oral evidence. However Cadent reserves its position in this regard.

Cadent's written representations dated 12 September 2019 are still applicable.
