I write on behalf of VPI Immingham B Limited ('VPIB' or the 'Applicant') in respect of the application (the 'Application') for a Development Consent Order ('DCO') to construct, operate and maintain a new gas-fired electricity generating station with a gross output capacity of up to 299 megawatts ('MW'), including electrical and gas supply connections, and other associated development (the 'Proposed Development'). The Proposed Development is located primarily on land (the 'Site') to the north of the existing VPI Immingham Power Station, Rosper Road, South Killingholme, North Lincolnshire, DN40 3DZ.

The Application was accepted for examination (the 'Examination') on 9 May 2019 and the Examination began on 09 August 2019.
