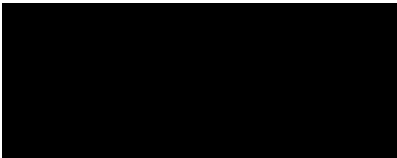
The Statement of Common Ground ('SoCG') with Natural England ('NE') is now signed and final. The SoCG with North Lincolnshire Council is agreed, aside from in respect of Requirement 19. The latter is therefore still a draft.

The Applicant submitted an updated DCO at Deadline 3. Since then the Applicant has not made or agreed any changes to the articles or requirements, and nor have any protective provisions been finalised. The Applicant's Responses to the Further Written Questions (Document Ref: 7.15) notes administrative changes to the DCO to refer to the updated Land Plans and Access and Rights of Way Plans submitted with this letter. Those will be included in an updated DCO to be submitted at Deadline 5, along with any other changes to the DCO agreed before then.

I trust that this letter provides the information required from the Applicant for Deadline 4 of the Examination.
