The Examining Authority (ExA) notified Interested Parties (IPs) on 5 November 2019 of the decision to hold a further Issue Specific Hearing on the dDCO.

Purpose of the Hearings

The main purpose of ISH3 is to discuss outstanding issues in respect of the drafting of the dDCO and to agree expectations moving forward.

For the avoidance of doubt, the hearing will not consider the underlying issues arising from the Application or the representations which have been made in relation to those issues. Furthermore, the decision to hold the hearing should not be taken to imply that the ExA has reached any view at this stage of the examination as to whether or not the Order should be granted.

Invited Participants

The Applicant, all IPs and Affected Persons are invited to attend. However, participation is subject to the ExA's power to control the hearing.

Representation, conduct and management of hearing

Participants may be legally represented if they wish, but the hearings will be conducted to ensure that legal representation is not required.

Guidance under the Planning Act 2008 and the Infrastructure Planning (Examination Procedure) Rules 2010 provide that it is the ExA that will probe,

test and assess the evidence through direct questioning of persons making oral representations at hearings. Questioning at the hearing will be led by the ExA.
