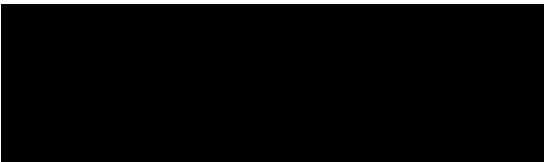
It is the Applicant's understanding that all matters in Statement of Common Grounds ('SoCG') with North Lincolnshire Council ('NLC') are agreed, including the revised wording of Requirement 19. The SoCG has been sent to NLC for signing, but the authority has not yet responded. The Applicant therefore anticipates submitting a final signed version at Deadline 6.

The Applicant's submission does not include a specific document setting out its comments on other parties' responses to the Examining Authority's Further Written Questions. This is intentional on the basis that (i) many of the issues raised by Interested Parties have been raised and responded to previously; and (ii) the Applicant has addressed the issues raised in other documents forming part of the Deadline 5 submission (Document Refs: 7.19 and 7.20).

I trust that this letter provides the information required from the Applicant for Deadline 5 of the Examination.
