I am writing to you in respect of the Written Representation that we submitted back on 11th September 2019 and the Deadline 7 of today, 6th February 2020.

While I am **not** in a position today to withdraw our objections to the proposed project as described in our Written Representation, I can confirm that following recent meetings between Total Lindsey Oil Refinery Limited and VPI Immingham B Limited we are close to a form of agreement that may allow us to withdraw our objections in the near future.

Our first objection related to the risk of siting the OCGT close to our existing restaurant site, the following proposals are being discussed to mitigate the associated risks are...

- Total Lindsey Oil Refinery Limited and VPI Immingham B Limited to agree an accurately located boundary line on the southern side of our Rosper Road Car Park, with VPI undertaking to relocate our restaurant if any developments encroaches north of that boundary;
- VPI Immingham B Limited agree to relocate the restaurant if any development poses a risk to
 our continued quite enjoyment of the restaurant in its current location, such risk include (but
 are not limited to) potential blast zones, noise pollution, restricted access, etc...
- Total Lindsey Oil Refinery Limited and VPI Immingham B Limited to agree a traffic management system for both construction and operational phases of the development so that vehicle ingress and egress from the proposed facility using our access roads does not interfere with the continued use of the remainder of the Rosper Road Car Park and allows safe vehicular and pedestrian access to the restaurant (if said restaurant does not require relocation).

Our second objection related to the method of construction, operational use and maintenance of the 700mm Natural Gas Pipeline linking the existing VPI site to the proposed site and of the Existing Gas Pipeline in the vicinity of our pipeline "Finaline". I understand protective provisions are included in the final planning application, once confirmed as suitable mitigation, any such protective provision will allow us to withdraw our second objection.

While I accept that the examination is due to close on 8th February, we undertake to keep both the Planning Inspectorate and relevant Secretary of State informed of further progress.
