The Statement of Common Ground ('SoCG') with Able is now signed with all matters agreed.

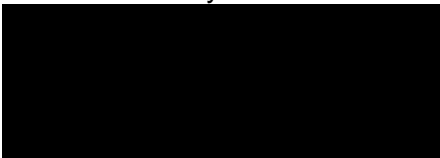
