## Hornsea Project Four Offshore Wind Farm DCO (the "Proposed Development") NEO Energy (SNS) Limited ("NEO")

We act on behalf of NEO Energy (SNS) Limited (Company Number SC291165 and having its registered office at The Silver Fin Building (9th Floor), 455 Union Street, Aberdeen, United Kingdom, AB11 6DB). Relevant representations were submitted on behalf of NEO in respect of the Proposed Development on 15 December 2021.

NEO considers that the impacts of the Proposed Development on its operations are of a suitably complex and technical nature and, as such, would benefit from submissions at the relevant Issue Specific Hearings. Accordingly, we hereby notify the Examining Authority that NEO, represented by its agents CMS, wishes to speak at the following Issue Specific Hearings:

- 1. Issue Specific Hearing (ISH1) on the draft DCO to be held on Tuesday 12 April 2022; and
- 2. Issue Specific Hearing (ISH3) on offshore environmental matters to be held on Tuesday 26 April 2022.

As mentioned in the relevant representations, and in NEO's response submitted at the Procedural Deadline, NEO continues to discuss matters with Orsted with a view towards resolving its concerns. Subject to the satisfactory resolution of those discussions, it may be that NEO's participation at the above Issue Specific Hearings is no longer required, and we will advise the Examining Authority accordingly in due course should participation no longer be required.
