We refer to our recent request to attend the ISH9 hearing session, to be held on Tuesday 19 July 2022.

We confirm that we have been actively engaged in constructive discussions with the promoters of the Hornsea Project Four Offshore Wind Farm Project and are increasingly confident that a satisfactory settlement can be reached in response to our concerns relating to the interaction of this DCO project with the interconnector that is currently under construction by National Grid Viking Link Ltd.

It is anticipated that early settlement can now be reached in provision of a suitable commercial agreement with Orsted Hornsea Project Four Limited and that very limited benefit would be gained in reviewing these arrangements with the Examining Authority. We confirm, in the circumstances, that we no longer need to attend the session on Tuesday 19th July and we withdraw our previous objection against Orsted application for an Order Granting Development Consent. We take this opportunity to thank you for your prompt assistance in dealing with our earlier request.
