We are pleased to enclose the Applicant's responses to Deadline 7 along with the other requested deliverables.

The Applicant's Deadline 8 submissions include responses to two Rule 17 letters issued 28 July 2022 and 11 August 2022. The responses to these can be found in the Applicant's submissions G8.2 Applicant's comments on the Report for Implications for European Sites (RIES) and G8.4 Applicant's response to Rule 17 Letter dated 11 August 2022.

The Applicant notified PINs via email on 18 August 2022, that the validation of the DCO SI template is taking longer than usual owing to the number of Orders currently being run through the system. As a result, this may not be provided before the 11:59 Deadline 8 cut off. It has been agreed that the Applicant will submit this document to the Examining Authority as soon as it becomes available.

Please note that the Draft DCO wording in the Compensation Roadmaps (REP7-021, REP7-023, REP7-027, REP7-029, REP7-031) submitted at Deadline 7 has not been updated to reflect the amendments made in G3.12 Without Prejudice Derogation Draft Development Consent Order (DCO) Schedules (REP7-079) at Deadline 7. The updated Draft DCO (C.1.1 Draft Development Consent Order (DCO) (REP7-039)) and the Compensation Plans submitted at Deadline 7 have the correct Draft DCO wording (presented in Section 5 in B2.7 Flamborough and Filey Coast (FFC) Special Protection Area (SPA) Kittiwake Compensation Plan (REP7-019) and Section 6 in B2.8 Flamborough and Filey Coast (FFC) Special Protection Area (SPA) Guillemot and Razorbill Compensation Plan (REP7-027)).

The Applicant has progressed an Agreement of Undertaking relating to s135 consent with The Crown Estate. There are a couple of minor outstanding points and an update will be provided as soon as the document is complete. The Applicant intends to provide an updated Schedule of Agreements (G6.18) on Monday 22nd August as there are a small number of agreements where completion is imminent and the Applicant believes
