Paragraph 2 of Part 1 of Schedule 16: Plan for Work of the Offshore Ornithology Engagement Group (OOEG)

Orsted Hornsea Project Four (UK) Limited (**Hornsea Four**) is writing to you in relation to the enclosed plan for the work of the OOEG for the kittiwake compensation measures required by Schedule 16 of the Order (**Plan of Work**).

Paragraph 2 of Part 1 of Schedule 16 requires the Plan of Work to be submitted to and approved by the Secretary of State prior to commencement of the authorised development.

The Plan of Work must include the details listed in sub-paragraphs (a) to (e) of paragraph 2 relating to terms of reference, membership, scheduling of meetings and timetabling for preparation of the Kittiwake Compensation Implementation and Monitoring Plan and related reporting and review periods, plus the dispute mechanism and scope of work.

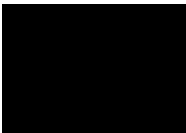
