The Examining Authority’s reasoning

The Applicant’s covering letter raises some procedural matters for discussion at the Preliminary Meeting to be held on 20 April 2021. It is therefore appropriate that this covering letter is accepted as an Examination document.

The covering letter also provides explanations for the submission of the updated documents listed above. For the most part the updates made to the documentation concern: the making of corrections or the provision of clarifications that were raised in the section 51 advice issued by the Planning Inspectorate on 23 December 2020 [PD-002]; or to address errors identified by the Applicant. The corrections and clarifications provided in the above listed documents do not materially alter the case made by the Applicant for the Proposed Development. The Examining Authority therefore considers that the acceptance of these documents into the Examination would not be prejudicial to the Interested Parties.

Low resolution plans submitted on 8 April 2021

On the 8 April the Applicant also submitted the following plans:

- 1) Land Plan Including Order Limits
- 2) Environmental Designations Plan: Habitats
- 3) Statutory and Non-Statutory Sites of Ecological Importance
- 4) Statutory and Non-Statutory Sites of Geological Importance
- 5) Works Plan

These low-resolution plans have been submitted by the Applicant for use at Examination hearings, in response to Procedural Decision 7 set out in the Rule 6 letter of 23 March 2021 [Appendix F of PD-004]. These plans are identical to Examination documents APP-006, APP-007, APP-008, APP-009 and APP-013. Accordingly, to avoid any confusion that might be caused by duplication, the low-resolution version of plans will not be added to the Examination Library.
