NORTH LINCOLNSHIRE BOROUGH COUNCIL AIR QUALITY MANAGEMENT AREA (NO.2) ORDER 2018

North Lincolnshire Borough Council, in exercise of the powers conferred on it by Section 83 (2) (a) of the Environment Act 1995 HEREBY makes the following Order to amend the North Lincolnshire Borough Council Air Quality Management Area Order 2005 (seal 4813).

This Order may be cited as the North Lincolnshire Borough Council Air Quality Management Area (No.2) Order and shall come into effect on the date which this Order is sealed.

The effect of this Order shall be to amend the boundary of the designated Air Quality Management Area. The area shown in blue on schedule 1 is to be designated as an Air Quality Management Area (the designated area). The designated area incorporates part of the town of Scunthorpe and an area of land to the east of Scunthorpe in the Borough of North Lincolnshire. The northern eastern boundary of the designated area runs south following the 1k eastern gridline of 495 from National Grid Reference 495000 412843 to 495000 406981 on the A18 Mortal Ash Hill Road. The boundary then runs west north west along the A18 to the junction with B1501 Grange Lane North. The boundary then runs north on Grange Lane North and then West along Warley Road until the junction with Healey Road. The boundary then runs north along Healey Road, crossing East Common Lane and continuing north on Warwick Road. The boundary then runs west on Cottage Beck Road and continues north along Trent Street. At the end of Trent Street, the boundary runs west along Rowland Road, then north along the Frodingham Footbridge crossing the railway line. The boundary then heads north east along Station Road and then north along Carlton Street until the end of Carlton Street. The boundary then crosses Church Square and on to High Street. At High Street the boundary runs east, over Brigg Road and on to Dawes Lane. The boundary continues along Dawes Lane until it reaches the railway line. The boundary follows this railway line heading east and passing through Santon until it reaches National Grid Reference 495000 412843.

The Area is designated in relation to a likely breach for particulate matter less than 10 microns in diameter (PM10) 24 hour mean as specified in the Air Quality Regulations 2000 as amended by Air Quality (Amendment) Regulations 2002.

This Order shall remain in force until it is varied or revoked by a subsequent order.

This Order shall come into force on 19th March 2018


