During the Examination and most recently at Deadline 7, the Applicants have indicated that they plan to introduce further changes to the Order Limits. With regard to this, the Applicants would

provide the following updates:

- 1. Outfall options on the matter of the outfall options contained in the DCO Application (Work Nos. 5A and 5B); the study work associated with making the decision on the reuse of the existing outfall has now been completed – this, along with other factors, will allow the Applicants to make the decision on reuse, or not, of the outfall. Removal of the option that is not selected will be submitted as a change to the DCO Application during Examination. The Applicants consider that the removal of the outfall which is not selected will be solely a reduction in the Order Limits (and associated removal of land powers), resulting in no change to the environmental effects already considered in the ES (although this will be considered and reported on appropriately). The potential change has been known to all interested parties since the DCO Application was submitted. It is therefore considered that it would be a non-material change.
- Tees Dock Road at Deadline 7, the Applicants indicated that they would be bringing forward a change to the DCO Application associated with the access on Tees Dock Road. As negotiations are still ongoing for the main site option agreement with STDC, the Applicants are unable to submit a change request in respect of Tees Dock Road at this time.

The Applicants will continue to update the ExA on progress with regard to the above changes.
