The Proposed Net Zero Teesside Project (EN010103) (the "Project") Deadline 9 Submission

1. Introduction

1.1 As set out in our previous submissions, we act on behalf of Teesside Gas Processing Plant Limited ("TGPP") and Teesside Gas & Liquids Processing ("TGLP") in relation to the development consent application by Net Zero Teesside Power Limited and Net Zero North Sea Storage Limited (together the "Applicants") for the Project (the "Application" or the "DCO"). TGLP and TGPP's interests are managed by North Sea Midstream Partners ("NSMP") and they will hereafter be referred to for ease of reading as NSMP.

2. Request to Speak at Issue Specific Hearing 5

2.1 On behalf of NSMP, we enumerated various concerns relating to the Project in our previous submissions (REP3-018, REP4-043, REP5-041 and REP6-142). Whilst NSMP have continued to engage with the Applicants and are in advanced discussions, NSMP would like to request to speak at Issue Specific Hearing 5 on the draft Development Consent Order ("dDCO") on Tuesday 18 October 2022 in order to reserve our position further should discussions with the Applicants not be resolved before the end of the Examination. Our attendance will be virtually via Microsoft Teams.

3. Draft Development Consent Order

3.1 We note that the Applicants submitted an updated dDCO at Deadline 8 (REP8-005). This included the addition of NSMP as consultee to certain requirements as requested by NSMP. However, the Applicants have not amended Table 7 in Schedule 7 of the dDCO. NSMP have previously noted that plot 106 should not be listed in connection with Work No. 10 and should be removed from this list and instead a new Work No. created which grants purely access rights over plot 106 for the purposes of work on plot 105. This is a critical point for NSMP given the location of this plot and its importance to the wider NSMP
