Following a review of the Book of Reference (Document Ref. 3.1) and the Statement of Reasons (Document ref. 3.2) the Applicants can confirm that there are no updates required at this time.

The Applicants are not proposing to update the Strategic Flood Risk Assessment (SFRA) mapping submitted for Stockton-on-Tees (Document Ref. 6.3.26b) as based on consultation with the Stockton-on-Tees Lead Local Flood Authorities the original SFRA mapping submitted as part of the DCO Application remains current.

At Deadline 8 the Applicants indicated that they planned to introduce further changes to the Order Limits in relation to the outfall options (Work Nos. 5A and 5B) and the Tees Dock Road. The Applicants are unable to submit a change request in respect of these changes at this time and will provide a further update at Deadline 10.

The Applicants confirm their intention to speak at ISH5, CAH 3 and ISH 6 on 18th and 19th October and also to attend the ASI requested by the North Tees Group of Companies to be held on 20th October.

I would be grateful if you could confirm receipt of this email and the Deadline 9 documents.
