

The Net Zero Teesside Order – Guide to Land Plan Plots

The purpose of this document is to report changes to plot numbers and provide reason for changes between DCO submissions. It relates each Work Number to the amended plots, thereby explaining what the underlying intent is for seeking the rights specified.

The first version of the guide to land plan plots document [AS-143] was provided alongside the first change request dated 28 April 2022, and set out the changes made to the Land Plans between version 2 dated October 2021 [AS-006] and version 3 dated April 2022 [AS-146] submitted as part of the change request on 28 April 2022.

The second version of the guide to land plan plots related to the second change request dated 23 August 2022, and showed the changes between the Land Plans version 3 dated April 2022 [AS-146] and version 4 dated August 2022 [REP6-014].

The third version of the guide to land plan plots relates to the third change request dated 1 November 2022, and shows the changes between the Land Plans version 4 dated August 2022 [REP6-014] and version 5 dated October 2022 [REP12-015].

This fourth version of the guide to land plan plots relates to the removal and reduction of plots in order to remove the Tees Dock Road access. This shows the changes between Land Plans version 5 dated October 2022 [REP12-015] and version 6 dated March 2023 (Document Ref 4.2).

Where plot nos. have “Number not used” in the Acquisition Type column and “N/A” in the Reason For Plot No. Change column in this version, they are related to plot removals under the first, second and third change requests accepted into Examination by the Examining Authority [PD-010, PD-017 & PD-023 respectively].
