The Net Zero Teesside Order  $2024(\mathbf{a})$  ("the 2024 Order") which granted development consent within the meaning of the Planning Act  $2008(\mathbf{b})$  ("the Act") contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant(c) for the correction of errors and omissions in the 2024 Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed the local planning authority for the area in which the land to which the 2024 Order relates is situated as the relevant planning authority, that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraph 1(4) and (8) of Schedule 4 to, the Act, makes the following Order:
