**Request by the Applicant in Respect of the Timing of the Preliminary Meeting / Examination**

Thank you for your letter dated 4<sup>th</sup> May 2022 inviting comments on whether the Preliminary meeting should be delayed until mid-July 2022 and the applicants proposed timetable.

On behalf of Godolphin, confirm that the proposed delay will cause prejudice to interested parties, of which we are one. Godolphin is an international bloodstock racing and breeding operation that is at its busiest in July, not just in the UK but in France, Ireland and the USA where we are sending horses to race at the premier race meetings.

Godolphin will not be able to respond in enough detail to the issues raised by this crucial Sunnica development in July and the whole matter will be prejudiced from the point of view of the bloodstock industry. You are requested to dismiss these amendments.
