Cambridgeshire County Council has no objection to the use of virtual methods for future Examination hearings and for there to be blended events where there is the ability to attend in person or virtually.

Agenda Item 4: Draft Examination Timetable – Annex D to Rule 6 letter

Cambridgeshire County Council would like to highlight the challenges associated with the first two deadlines scheduled in August. This is the height of the summer holiday season. This may affect the ability of local residents, parish councils, and personnel within the authorities to comment at specific times, and we ask that this is borne in mind when confirming the Examination timetable. This was raised in the joint response dated 18<sup>th</sup> May with the three other host authorities to the Examining Authority following the invitation to comment on the timing of the Preliminary Hearing.

Deadline 1 and Deadline 2 are set at 17 August 2022 and 30 August 2022, with the Local Impact Report due on 17 August and the Written Representation due on 30 August. This is particularly challenging in terms of personnel availability as well as there being no committee meetings scheduled in August and delegated authority needing to be used.

Cambridgeshire County Council asks if it were possible for the Examining Authority's third written questions be issued a week earlier (currently scheduled as 6<sup>th</sup> December) to assist those involved with meeting deadline 7 (22<sup>nd</sup> December). We note between these dates in December a number of days are reserved for Accompanied Site Inspections, Open Floor Hearings and Issue Specific Hearings making it a busy period in which to meet all that is requested as part of Deadline 7.

**Unaccompanied Site Inspections** 

Isleham

- Location: View from Beck Road on edge of Isleham village.
- Issues to be observed: Impact of Sunnica East site A on the landscape.
- Information on whether the site can be accessed via public land: Can be viewed in the car on the highway. There are no paths or layby to stop. However, it may be possible to ask The Arc Church to use their car park to be able to stop and observe the fields.
- The reason why the location has been suggested: Provides a good vantage point to view Sunnica East Site A and understand the landscape in context.

Limekilns Gallops

- Location: View from B1506 (Well Bottom).
- Issues to be observed: Impact of Sunnica West site A on the landscape.
- Information on whether the site can be accessed via public land: Can be viewed in the car on the highway. Layby is located approximately half a mile from the junction with the A1304.
- The reason why the location has been suggested: Provides a good vantage point to view Sunnica West Site A and understand the landscape in context.

Burwell

• Location: Weirs Drove, Burwell

• Issues to be observed: See the location of the substation and the vehicle route to the site.

- Information on whether the site can be accessed via public land: Can be viewed in the car on the highway.
- The reason why the location has been suggested: To see the location of the substation in the village of Burwell. Potential to travel to this location from Sunnica West site B by car on the local highway network and follow sections of the cable route to the Burwell substation.

• Location: Sunnica West site B

- The issues to be observed at the location: Archaeology and Ecology matters.
- Information on whether the site can be accessed via public land: Private access for which arrangements will need to be made and Cambridgeshire County Council can advise.
