I have particular interest in the above as I have a financial background and will be submitting a comprehensive report in my Written Representation.

However now that due to Sunnicas request to make changes to the DCO certain items they have submitted to the Planning Inspectorate will be out of date as the date for the examination is now being pushed right back to later in the year.

In the Funding statement they have submitted is included the annual accounts for the Parent Company of Sunnica Ltd which happens to be Spanish.

That company is Solaer Holding, S.L.and Subsidiaries Audited report Consolidated Financial Statements and Consolidated Directors report for the year ended 31st December 2020 which was signed off by Deloitte, S.L.on the 15th July 2021

Therefore the accounts for 31stDecember 2021 are now available.

Please can the Inspectors request Sunnica now, to produce those 2021 accounts in English and preferably converted to sterling.

Those presently with the planning inspectorate are in euros which is very misleading to a reader and should have been converted to sterling when included in their DCO.

Dear Michele

I write with reference to my letter to you and your response of the 4th August with my letter attached.

I apologise for having to write again but feel I must bring a matter of confusion to the Examining Inspectors attention and I will explain.

I refer to Pinsent Masons letter to the Planning Inspectorate of the 21st July 2022 and ref to Option 3 changes, heading Updated Crane Routing paras No 7 and 8.

Reference is only made to a **crane** that will oversail a small piece of land East of Freckenham down Mildenhall Road and then turning left into a un named road.

There is of course no reference to the dimensions of the crane or its weight or what the overhang is.

I now refer to the option on the Planning Inspectorate Sunnica website to refer to the developer's website.

That does not refer to a crane in any part of the particulars re the Option 3 change but rather to a heading AIL and that refers to plate 1 (**16 Axle Girder Trailer**) which will carry a huge transformer.

The AIL gives a sketch of the vehicle with the transformer sitting in the middle of the trailer unit.

Once again no dimensions are produced or the weight of the vehicle OR the transformer sitting on the vehicle and its overhang.

To conclude a decision must be made by the applicant;

is it a crane they are referring to?

or is it a 16 Axle Girder trailer with a 400KV transformer thereon?

The public, who are not being consulted in this instance, have a right to know all the answers to the above and what the overhang is on the vehicle involved. Furthermore those parties that are being consulted must know the answer to base a decision.

Please kindly ensure the Examining Inspectors are aware of my letter and kindly acknowledge receipt.
