The Traveller Community – Elms Road

Statement to be read out at the Public Open Floor Hearing and the Issue Specific Hearings into Sunnica.

We confirm we have given permission for the following statement to be read out in public on behalf of the Traveller Community Elms Road Red Lodge

We live permanently on Elms Road on a consented site. We have made this our home since 2017.

The first time we became aware of Sunnica was in October 2021. Before then we had seen signs in the roadside but did not know what they meant.

When we learnt what Sunnica was about from neighbours we have written letters objecting to Sunnica on 18th October 2021, and 6<sup>th</sup> August 2022.

Nobody from Sunnica or working for Sunnica has ever contacted us or tried to meet with us to explain what they are wanting to do. As the scheme is currently laid out we will have solar panels from Sunnica East Site B right up to our western boundary and the batteries will be just across the road to the north west.

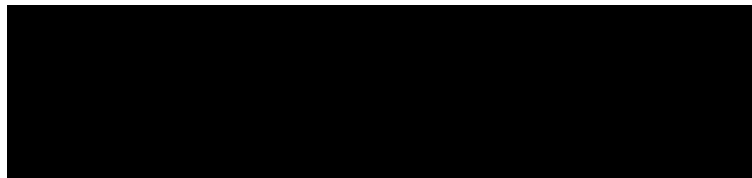
We will be the people living closest to any of the Sunnica sites, less than 10ms from an unscreened field of solar panels and less than 100m from the batteries. Despite this we have never been talked too by Sunnica.

We have heard that the accepted set back for solar panels from properties at Worlington is 500metres if we were shown that respect the batteries and the solar field would have to be set back from where they are now. WE have had this boundary drawn on a plan.

We are worried sick about the value of our property and the health and danger to our families. Sunnica should not be allowed to ignore us as they have.
