Article / Requirement number in draft DCO	Explanation of Change
Definition of "biodiversity strategy"	This definition has been updated to reflect the revised biodiversity strategy submitted at Deadline 6.
Definition of "varied condition"	<p>This definition has been updated to clarify that it relates to a condition:-</p> <ul style="list-style-type: none"> • imposed under a new planning permission (where such condition differs to the its predecessor under the planning permission originally granted on 12 April 2019) pursuant to section 73 of the Town and Country Planning Act 1990 (the "1990 Act"); • varied under section 96A of the 1990 Act; or • where the numbering has changed from the numbering under the original planning permission of 12 April 2019. <p>This change follows discussions with NELC.</p>
Article 5(7)(b)	Additional wording has been added to clarify the text in brackets, following discussions with NELC.
Requirement 19 (Investigation and remediation of contamination) and requirement 20 (Implementation of remediation scheme)	<p>The wording of requirements 19(5), 19(6), 20(1) and 20(2) has been updated to make clear that they apply to a remediation scheme insofar as a remediation scheme has been required under requirement 19(4).</p> <p>This change follows discussions with NELC.</p>
Requirement 35 (Combined heat and power)	<p>Requirement 35(7) previously stated:</p> <p><i>"The details approved under sub-paragraph (4) must be implemented as approved and maintained, unless otherwise agreed by the relevant planning authority."</i></p>

	The cross reference to sub-paragraph (4) was an error, and should be to sub-paragraph (6). This has been corrected, but for the ExA's information the comparison document does not show the change.
