1 Introduction

1.1 Purpose of Statement of Commonality

1. This document provides the Examining Authority (ExA) with an overview of each Statement of Common Ground (SoCG) between the Applicant (Equinor New Energy Limited) and interested parties (see ExA's **Rule 6 Letter** [PD-006]) in relation to SEP and DEP at Deadline <u>24</u>. This document will be updated and submitted at the requested deadlines outlined in the Examination timetable.



2 List of Statement of Commonality

 Table 2-1 provides the list of SoCGs that have been prepared by the Applicant in accordance with the list as requested by the Planning Inspectorate in Annex F of the Rule 6 letter [PD-006] issued on 13th December 2022.

2.1 Summary of Current Position of SoCGs

- 3. The SoCGs submitted alongside this document at Deadline 2 reflect the current position of the Applicant and stakeholders.
- 4. **Table 2-1** provides an overview of the status of each SoCG throughout the examination.

2.2 SoCGs not being submitted at Deadline 2

2.2.1 Anglian Water Services

5. Anglian Water is aware of the forthcoming change to remove the drainage option to discharge surface water into an Anglian Water foul sewer at the Onshore Substation. The intention is to make this change <u>A non-material change application</u> is made as part of theat Deadline 2 submission. Anglian Water agree that if a Statement of Ground is required after this change is made, it will be progressed after the change application is made following Deadline 2.

2.2.2 Chamber of Shipping

6. An initial draft SoCG has been prepared and is being considered by the Chamber of Shipping (CoS). It is anticipated that the Applicant will be in a position to submit a SoCG with the CoS at Deadline 2 or 3.

2.2.32.2.2 East of England Ambulance Service NHS Trust

7.6. The Applicant and the East of England Ambulance Service NHS Trust (EEAST) have engaged in the process of drafting a SoCG and have agreed to submit a SoCG at Deadline 3.

2.2.42.2.3 East Suffolk Council

- 8.7. The Applicant and East Suffolk Council (ESC) have agreed not to submit a SoCG into Examination at Deadlines 1 or 2. This decision has been taken recognising that the Applicant is not actively pursuing its project-led proposal for kittiwake nest site improvements at Lowestoft at this time due to the following:
 - Concerns raised by ESC in their Relevant Representation [RR-030], specifically, the Council's objection to the proposal and preference to see compensation for offshore wind development being delivered more strategically or collaboratively;
 - Concerns raised by Natural England in their Relevant Representation [RR-063]; and

- Given that delivery of the Applicant's alternative project-led proposal for kittiwake nest site improvements at Gateshead is progressing positively and alone is considered sufficient to fully meet SEP and DEP's compensation requirements for kittiwake.
- 9.8. The Applicant and ESC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.52.2.4 Eastern Inshore Fisheries and Conservation Authority

<u>10.9.</u> Discussions are ongoing between the Applicant and Eastern Inshore Fisheries and Conservation Authority (EIFCA) with the intention to submit a SoCG at Deadline <u>32</u>.

2.2.62.2.5 Historic England (Offshore and Onshore)

11.10. The Applicant and Historic England has been in discussions surrounding the preparation of an offshore a joint Offshore and Onshore SoCG and an initial draft has been prepared. Discussions are ongoing and it is anticipated that the Applicant will be in a position to submit a SoCG with Historic England at Deadline 23.

2.2.7 Historic England (Onshore)

12. The Applicant and Historic England have been in discussions surrounding the preparation of an onshore SoCG and an initial draft has been prepared. This will be reviewed following receipt of the Historic England's Local Impact Report and it is anticipated that a SoCG will be subsequently progressed and the Applicant will be in a position to submit a SoCG with Historic England at Deadline 2.

2.2.82.2.6 Independent Oil and Gas

13.11. Discussions are ongoing between the Applicant and Independent Oil and Gas (IOG) with the intention to submit a SoCG at either Deadline 2 or 3.

2.2.92.2.7 National Farmers Union

14.12. An initial draft SoCG has been prepared and is being considered by the National Farmers Union (NFU) with a meeting held to discuss the SoCG on 2nd March. --It is anticipated that the Applicant will be in a position to submit a that the SoCG with the NFU will be submitted at either Deadline 2 or 3.

2.2.10 National Trust

15. The Applicant <u>has submitted and National Trust are continuing discussions and aim</u> to submit a <u>draft SoCG</u>Statement of Common Ground with National Trust at Deadline 2. As requested by the ExA, the Applicant and National Trust have agreed milestones for entering into a voluntary land agreement. These are set out in the response to Q1.8.3.2(a) of the Examining Authority's Written Questions (WQ1) [PD-010] (see The Applicant's Responses to the Examining Authority's First Written Questions [REP1-03612.4]) and below for ease of reference:

2.2.112.2.8 National Air Traffic Services

16.13. An initial draft SoCG has been prepared and is being considered by the National Air Traffic Services (NATS). It is anticipated that the Applicant will be in a position to submit a SoCG with NATS at either Deadline 2 or 3. The Applicant and National Air Traffic Services (NATS) have agreed not to submit a SoCG into Examination. The Applicant and NATS are in discussion regarding entering a Mitigation Services Contract.

2.2.12 Natural England

- 17. The Applicant has has consulted with Natural England during the early stages of Examination and sought feedback on key technical notes which have also supported the drafting of onshore and offshore SoCGs.
- 18. Draft SoCGs with Natural England on Onshore and HRA Derogation matters were submitted at Deadline 1. The following draft SoCGs have been submitted Due to resourcing constraints, the following SoCGs drafted between the Applicant and Natural England will be submitted at Deadline 2:;
 - Draft SoCG Natural England (Offshore); and
 - Draft SoCG Natural England (Offshore Ornithology).

2.2.132.2.9 Norfolk Wildlife Trust

19. The Applicant and the Norfolk Wildlife Trust (NWT) have engaged in the process of drafting a SoCG. Discussions are ongoing and it is expected that a SoCG will be submitted at either DDeadline 2 or 3.

2.2.14 North Norfolk District Council

20. The Applicant and North Norfolk District Council (NNDC) have engaged in the process of drafting a SoCG. Discussions are ongoing and it is expected that a SoCG will be submitted at Deadline 2.

2.2.152.2.10 Norwich Airport

21.14. The Applicant and Norwich Airport have engaged in the process of drafting a SoCG. Discussions are ongoing and it is expected that the Applicant will be in a position to submit a SoCG at either Deadline 2 or 3.

2.2.16 Norwich City Council

22. The Applicant and Norwich City Council have agreed not to submit a SoCG into Examination at Deadline 1. It is anticipated that the Applicant will be in a position to submit a SoCG with Norwich City Council at Deadline 2.



2.2.172.2.11 Perenco

23.15. Discussions are ongoing between the Applicant and Perenco with the intention to submit a SoCG at either Deadline 2 or 3.

2.2.182.2.12 REAF CIC

24.<u>16.</u> Discussions are ongoing between the Applicant and REAF CIC with the intention to submit a SoCG at Deadline 2. The Applicant and REAF CIC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.192.2.13 Royal Society for the Protection of Birds

25.17. Due to resourcing constraints, a SoCG between the Applicant and the Royal Society for the Protection of Birds (RSPB) will not be submitted at Deadline 24. It is anticipated that the Applicant will be in a position to submit a SoCG with RSPB at Deadline 32.

2.2.202.2.14 Statutory Undertakers

- 26.18. Protective provisions discussions are ongoing with a number of statutory undertakers; therefore, the Applicant has decided that a SoCG is not necessary for Deadline 24. The Applicant will instead provide a note to update the ExA on the status of the negotiations taking place between the Applicant and statutory undertakers; please refer to The Applicant's Statutory Undertakers Position Statement [REP1-053document reference 12.46] submitted at Deadline 1.
- 27.19. The Applicant will not be preparing a SoCG with the following statutory undertakers where ongoing discussions surrounding protective provisions are taking place:
 - Orsted Hornsea Project Three (UK) Limited;
 - Vattenfall Wind Power Limited;
 - Cadent Gas Limited;
 - Frontier Power;
 - UK Power Networks Limited;
 - Network Rail Infrastructure;
 - National Grid Gas Plc;
 - National Grid Electricity Transmission; and
 - Norfolk Rivers Internal Drainage Board.
