This document will be updated and submitted at the requested deadlines outlined in the Examination timetable.

# 2.2 SoCGs not being submitted at Deadline 23

# 2.2.1 Anglian Water Services

5. Anglian Water is aware of the forthcoming change to remove the drainage option to discharge surface water into an Anglian Water foul sewer at the Onshore Substation. A non-material change application is made as part of the Deadline 2 submission which has been accepted. Anglian Water agree that if a Statement of Ground is required after this change is made, it will be progressed following Deadline 2. The Applicant and Anglian Water are in discussions about whether a Statement of Common Ground is necessary.

# 2.2.2 East of England Ambulance Service NHS Trust

The Applicant and the East of England Ambulance Service NHS Trust (EEAST)
have engaged in the process of drafting a SoCG and have agreed to submit a SoCG
at Deadline 3.

#### 2.2.2 Broadlands District Council

6. Engagement between the Applicant and Broadland District Council is ongoing and it is anticipated that an updated Statement of Common Ground will be submitted at Deadline 4.

#### 2.2.3 East Suffolk Council

- 7. The Applicant and East Suffolk Council (ESC) have agreed not to submit a SoCG into Examination at Deadlines 1, or 2 or 3. This decision has been taken recognising that the Applicant is not actively pursuing its project-led proposal for kittiwake nest site improvements at Lowestoft at this time due to the following:
  - Concerns raised by ESC in their Relevant Representation [RR-030], specifically, the Council's objection to the proposal and preference to see compensation for offshore wind development being delivered more strategically or collaboratively;
  - Concerns raised by Natural England in their Relevant Representation [RR-063];

- Given that delivery of the Applicant's alternative project-led proposal for kittiwake nest site improvements at Gateshead is progressing positively and alone is considered sufficient to fully meet SEP and DEP's compensation requirements for kittiwake.
- 8. The Applicant and ESC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

#### 2.2.4 Eastern Inshore Fisheries and Conservation Authority

9. Discussions are ongoing between the Applicant and Eastern Inshore Fisheries and Conservation Authority (EIFCA) with the intention to submit a SoCG at Deadline 3.

# **2.2.5**2.2.4 Historic England (Offshore and Onshore)

10. The Applicant has forwarded a copy of a draft Statement of Common Ground to and Historic England and is awaiting feedback. It is anticipated that a draft Statement of Common Ground will be submitted inat a future deadline. has been in discussions surrounding the preparation of a joint Offshore and Onshore SoCG and an initial draft has been prepared. Discussions are ongoing and it is anticipated that the Applicant will be in a position to submit a SoCG with Historic England at Deadline 34.

#### 2.2.62.2.5 Independent Oil and Gas

11. Discussions are ongoing between the Applicant and Independent Oil and Gas (IOG) with the intention to submit a SoCG at Deadline 34.

#### 2.2.72.2.6 National Farmers Union

12. An initial draft SoCG has been prepared and is being considered by the National Farmers Union (NFU) with a meeting held to discuss the SoCG on 2<sup>nd</sup> March. Further meetings have Engagement is ongoing and a further meetings had been arranged on the 25<sup>th</sup> April but was cancelled by the NFU. The Applicant is seeking to rearrange the discussion and will submitting a SoCG at the earliest opportunity Further discussion is planned for May and ltt is anticipated that the SoCG will be submitted at Deadline 435.

#### 2.2.82.2.7 National Air Traffic Services

13. The Applicant and National Air Traffic Services (NATS) have agreed not to submit a SoCG into Examination. The Applicant and NATS are in discussion regarding entering a Mitigation Services Contract.

#### 2.2.8 National Trust

14. Engagement between the Applicant and National Trust is ongoing and it is anticipated that an updated Statement of Common Ground will be submitted at Deadline 4.

### **2.2.142.2.15** Royal Society for the Protection of Birds

19.21. Due to resourcing constraints, a SoCG between the Applicant and the Royal Society for the Protection of Birds (RSPB) will not be submitted at Deadline 23. It is anticipated that the Applicant will be in a position to submit a SoCG with RSPB at a later Deadline 3 The RSPB has indicated to the Applicant that it is committed to delivering a SoCG however due to resource constraints within the RSPB there has not been time to fully review the extra material submitted since the DCO application. Therefore, the RSPB and the Applicant have agreed to submit a SoCG before the end of Examination.




