1 Introduction

1.1 Purpose of Statement of Commonality

1. This document provides the Examining Authority (ExA) with an overview of each Statement of Common Ground (SoCG) between the Applicant (Equinor New Energy Limited) and interested parties (see ExA's Rule 6 Letter [PD-006]) in relation to SEP and DEP at Deadline 45. This document will be updated and submitted at the requested deadlines outlined in the Examination timetable.

2 List of Statement of Commonality

2. **Table 1** provides the list of SoCGs that have been prepared by the Applicant in accordance with the list as requested by the Planning Inspectorate in Annex F of the **Rule 6 letter** [PD-006] issued on 13th December 2022.

2.1 Summary of Current Position of SoCGs

- 3. The SoCGs submitted alongside this document at Deadline 4–5 reflect the current position of the Applicant and stakeholders.
- 4. **Table 1** provides an overview of the status of each SoCG throughout the examination.

2.2 SoCGs not being submitted at Deadline 5

2.2.1 Anglian Water Services

5. Anglian Water is aware of the forthcoming change to remove the drainage option to discharge surface water into an Anglian Water foul sewer at the Onshore Substation. A non-material change application is made as part of the Deadline 2 submission which has been accepted. The Applicant and Anglian Water have agreed that it is not necessary to submit a SoCG at Deadline 4 and will consider further whether it is necessary to submit a SoCG at a future deadline.

2.2.1 Broadland District Council

6. Engagement between the Applicant and Broadland District Council is ongoing and it is anticipated that an updated SoCG will be submitted at D6.

2.2.2 East Suffolk Council

- 6.7. The Applicant and East Suffolk Council (ESC) have agreed not to submit a SoCG into Examination_at Deadlines 1,2, 3 or 4. This decision has been taken recognising that the Applicant is not actively pursuing its project led proposal for kittiwake nest site improvements at Lowestoft at this time due to the following:
 - Concerns raised by ESC in their Relevant Representation [RR-030], specifically, the Council's objection to the proposal and preference to see compensation for offshore wind development being delivered more strategically or collaboratively;
 - Concerns raised by Natural England in their Relevant Representation [RR-063];
 and
 - Given that delivery of the Applicant's alternative project-led proposal for kittiwake nest site improvements at Gateshead is progressing positively and alone is considered sufficient to fully meet SEP and DEP's compensation requirements for kittiwake.
- 7. The Applicant and ESC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.3 Environment Agency (EA)

8. Engagement regarding the Protective Provisions with the EA is ongoing. It is anticipated that an updated Statement of Common Ground will be submitted at Deadline 7.

2.2.32.2.4 Historic England (Offshore and Onshore)

8.9. The Applicant has forwarded a copy of a draft Statement of Common Ground to Historic England and is awaiting received feedback on onshore matters on 13th June 2023. It is anticipated that AA combined draft Statement of Common Ground for onshore and offshore matters is being prepared and will be submitted at a future deadline prior to the end of the Examination.

2.2.42.2.5 Independent Oil and Gas

9.10. <u>Discussions are ongoing between tThe Applicant and Independent Oil and Gas</u> (IOG) may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so. with the intention to submit a SoCG at Deadline 56.

2.2.5 National Farmers Union

10.11. An initial draft SoCG has been prepared and is being considered by the National Farmers Union (NFU) with a meeting held to discuss the SoCG on 2nd March. Engagement is ongoing and a further meeting had been arranged on the 25th April but was cancelled by the NFU. The Applicant is seeking to rearrange the discussion and will be submitting a SoCG at the earliest opportunity.

2.2.6 National Air Traffic Services

12. The Applicant and National Air Traffic Services (NATS) have agreed not to submit a SoCG into Examination. The Applicant and NATS are in discussion regarding entering a Mitigation Services Contract.

2.2.7 National Trust

13. Engagement between the Applicant and National Trust is ongoing and it is anticipated that an updated Statement of Common Ground will be submitted at Deadline 4 prior to the end of Examination. As noted in response to Q3.14.1.6 in The Applicant's Responses to the Examining Authority's Third Written Questions [document reference 19.2], the Applicant was invited by the National Trust and Natural England to a meeting on 08 June 2023, to discuss an additional potential compensatory measure option involving rat eradication at Blakeney (i.e. within the North Norfolk Coast Special Protection Area), which has the support of both the National Trust and Natural England. Therefore, these proposals will be included in an updated version of the SoCG.

2.2.8 Natural England

14. A Statement of Common Ground between the Applicant and Natural England will be submitted at the end of Examination

2.2.7 National Highways

Engagement between the Applicant and National Highways is ongoing with the latest SoCG submitted at D3. It is anticipated that the SoCG will be updated and submitted again at a future deadline.

2.2.82.2.9 North Norfolk District Council

41.15. Engagement between the Applicant and North Norfolk District Council is ongoing and it is anticipated that an updated Statement of Common Ground will be submitted at Deadline 5-6if necessary.

2.2.92.2.10 Norwich City Council

The Applicant and Norwich City Council have agreed not to submit a SoCG into Examination.

2.2.11 Norfolk Wildlife Trust

12.17. The Applicant and the Norfolk Wildlife Trust (NWT) have engaged in the process of draftingsubmitted a SoCG at Deadline 4 [REP4-026]. Discussions are ongoing with respect to outstanding offshore matters (all onshore matters are agreed) and it is expected that a final SoCG will be submitted at Deadline 4 prior to the end of Examination.

2.2.102.2.12 Perenco

13.18. Discussions are ongoing between the Applicant and Perenco with the intention to submit a SoCG at Deadline 57.

2.2.112.2.13 REAF CIC

14.19. The Applicant and REAF CIC may consider submitting a SoCG into Examination at a later stage should it be appropriate to do so.

2.2.122.2.14 Royal Society for the Protection of Birds

15.20. The RSPB has indicated to the Applicant that it is committed to delivering a SoCG however due to resource constraints within the RSPB there has not been time to fully review the extra material submitted since the DCO application. Therefore, the RSPB and the Applicant have agreed to submit a SoCG before the end of Examination.

2.2.15 South Norfolk Council

21. Engagement between the Applicant and South Norfolk Council is ongoing and it is anticipated that an updated SoCG will be submitted at Deadline 6.

2.2.132.2.16 Statutory Undertakers

16.22. Protective provisions discussions are ongoing with a number of statutory undertakers; therefore, the Applicant has decided that a SoCG is not necessary for Deadline 45 and a SoCG with the following stakeholders is not considered

2.3 Status of Other Statements of Common Ground

23. This section summarises the status of specific Statements of Common Ground which have been submitted at Deadline 5.

2.3.1 Anglian Water

Whilst a Statement of Common Ground with Anglian Water has been submitted with all items shown as 'agreed', the document has not yet been signed. Anglian Water would like to ensure that the full agreed protective provisions are translated into an updated DCO. A signed Statement of Common Ground will be submitted at a later deadline.

2.3.2 National Farmers Union (NFU)


25. The Applicant and NFU have been in discussions surrounding a Statement of Common Ground and a copy has been submitted at Deadline 5. The Applicant received comments back from the NFU on the latest draft of the Statement of Common Ground on Thursday 8th June and reverted with an updated draft on the 12th June. The Applicant would therefore like to make the Examining Authority aware that the NFU has not had much time to review the updates. Given the progress that has been made and that the updates do not impact the substance of the SoCG, the Applicant considers it beneficial to submit a copy nonetheless.







3 Summary of Commonality of Each Topic Covered


