Development Consent Order (DCO) application for Sheringham Shoal and Dudgeon Offshore Wind Farm Extension Projects (EN010109) – Examination Deadline 5 Document Submissions

1. DEADLINE 5 SUBMISSIONS

We refer to the Planning Inspectorate's Rule 8 Letter dated 30 May 2023 (the Rule 8 Letter). In accordance with the deadlines at Annex A of the Rule 8 Letter, Equinor New Energy Limited (the Applicant) encloses the documents listed in **Annex 1** of this letter in response to Deadline 5.

2. STATEMENTS OF COMMON GROUND

In the Planning Inspectorate's Rule 6 Letter dated 13 December 2022 (the Rule 6 Letter), Annex F requested that the Applicant submit Statements of Common Ground (SoCG) with a number of Interested Parties and Other Parties. A number of draft SoCGs were submitted at previous deadlines. The Applicant now encloses the draft SoCGs listed in **Annex 2** of this letter.
